

## AS OTHERS SEE US

Bakersfield Morning Echo: A call has been issued for a special election in the city of Los Angeles, June 12, to authorize an issue of \$23,000,000 in bonds for the so-called Owens River project and the language is noteworthy in several particulars. In the first place, it specifies the Owens River water supply by name, thus excluding all other projects, however advantageous they may be made to appear. It authorizes an issue of but \$23,000,000 when all of the estimates show that the project will cost much more than that. No one attempts to say how much the works will cost. It is a singular thing that a great city is about to embark on a gigantic enterprise without having had made anything in the nature of an estimate of the final cost. Expert engineers were called several months ago and after looking over the ground in an automobile for a few days, they said an open canal would cost about twenty-four and a half millions if the work was not done by a political organization. The report adds: "The figures are based on the assumption that the work will be done on a business basis, unaffected by politics." It is decided beforehand also that the work will be done "unaffected by politics." Los Angeles and no other city can do business that The police, health, street and all other departments of way. every city are deeply "affected by politics;" why should any one suppose that this great undertaking will be overlooked by the spoilsmen? In conversation with a number of prominent business men of that city a few days ago they all said they did not pretend to know what the undertaking would cost, but they placed the figure at thirty to forty millions. It is truly marvelous that a great city should embark on an enterprise of this magnitude clearly as a "leap in the dark."

We note also that the call for the election does not mention the power plant from which so much revenue has been promised, but expressly excludes it. The language of the call is as follows:

"That the object and purpose for which the said debt is proposed to be incurred is the followng to-wit:

"The acquisition and construction by the city of Los Angeles of a certain revenue-producing municipal improvement, to-wit: Waterworks for supplying the inhabitants of said city with water from the Owens River valley, in the state of California, including

the acquisition of lands, water rights, rights of way and other property and the construction of aqueducts, ditches, canals, tunnels, reservoirs and other works necessary therefor."

The words "and other works necessary therefor" must refer to the "water works for supplying the inhabitants with water." This must make the power companies breathe easier, and perhaps it would now be possible for a citizen of Los Angeles humbly to ask a question about the undertaking without being accused of being a "tool of the power companies."

The power phase of this Owens River project has been very nearly ludicrous from the beginning. It is admitted that nine or ten million dollars would bring to the city enough water to answer her needs up to about double her present population. Then until that point is reached, the balance of the thirty or forty millions of cost must be charged off to the power plant which has heretofore been talked about in glowing terms, and the inconsequential benefit flowing from the sale of a small amount of water to a few farmers. For this surplus investment of twenty or thirty millions of dollars, it is estimated that electrical energy to the amount of 49,000 continuous horse power could be produced. But the Edison company, at a cost of about \$1,750,000, is just completing a plant on Kern River that will turn into Los Angeles 40,000 horsepower. With substantially the same output, the city will have ten to fifteen times the investment of the power company. To deliver this power, Los Angeles will be to the expense of maintaining an expensive waterway 250 miles in length, and one power line 150 miles long, one of her proposed plants being that distance from the city; the Edison company has about ten miles of waterway to maintain, and a transmission line about 125 miles in length.

Of course, if Los Angeles has abandoned the idea of installing power plants, as the call for the election indicates, then this phase of the question is not up for further consideration. But with that source of income eliminated, the full load of this enormous debt must fall directly upon the inhabitants of the city. What circumstance can justify her in taking on a load of debt amounting to thirty or forty million dollars, when ten millions is enough to meet her needs for an indefinite length of time? When she has doubled her population (and wealth) and needs more water, the supply will still be exactly where it is now, and she will be twice as able as now to bring it in.

## PEOPLE WHO VOTE BONDS

There are four classes of people who can always be depended upon to vote for bonded indebtedness and they are unfortunately largely in evidence in this City, but fortunately not in the majority.

First are the Bankers. They live by the groth of debt and as long as there is money there will be money changers who feed upon usuary. They will always indorse any plan which will rob the people by interest bearing debt. When the property mortgaged can no longer pay the interest they will forclose and take it.

Second are Real Estate dealers and boomers, who will be in favor of any scheme which will create a temporary ficticious value. They are a species of gamblers, very numerous and have always been the curse of this part of California. No scheme is to big for them to indorse and the more rediculous and impossible the louder they will howl; any thing to raise prices temporarily.

Third, the Boodlers, Grafters, Newspapers, Surveyors; Shyster Lawyers and others who get a share of the peoples money; and Fourth, working people who have no property of their own and are not to honorable to vote a mortgage on other peoples property. I am glad to say that out of the thousands of such people in Los Angeles, there are many who will refuse to vote on a question which they realize is not within their right. There are however, thousands of tramps and drunken loafers who will vote for the bonds, partly for spite against successful people, and partly because they hope for a temporary raise in wages, knowing well that if it fails or when the work fails they can pack their grips or roll up their blankets and like the Arab "silently steal away," and help vote bonds at some other place.

There are not nearly so many people who vote as they are told by their preacher or banker as formerly, but of course there are a few who do not think for themselves and vote without knowing the reason why.

## THEY LIVE BY GRAFT

To one who has a great respect for the cloth, and a deep-rooted faith in the teachings of the church, it is a little jarring to find a local minister of the gospel announcing his intention to advocate the desert bond issue from his pulpit next Sunday evening, taking his text from Revelations 22:1, "He showed me a pure river." He explains that he believes in choosing his subject from living issues, "and, surely," he is quoted as naively saying, "there is no more living issue in Los Angeles today than the securing of the Owens river water by the \$23,000,000 of bonds."

Doubtless, the Rev. Mr. Brooks is a most helpful minister to his flock—naturally, he is a Baptist—but, before he begins likening Owens river to the pure water of life, such as was revealed to St. John the Divine, he should be sure of his premises. With analyses of eminent chemists of international reputation revealing the presence of large quantities of alkali in the river, with the testimony of ranchers and old-timers strongly corroborating the scientists by practical tests, resulting in their refusal to drink the water, Rev. Brooks is making a sorry exhibition of his pulpit, and is posing as a false prophet in attempting to lead his congregation astray in the manner he proposes.

Besides, we have plenty of good water hereabouts, and the mountain of debt sought to be imposed is entirely unnecessary.

Another minister, a Congregationalist, is advertising to give a lantern-slide lecture, the views, presumably, being furnished by the desert bonds promoters of the enterprise. What a chagrined pair of preachers these two gentlemen will find themselves, in case the bonds carry, when later events prove the fallacy of their doctrines, which, alas, they have, apparently, imbibed at second hand from selfish sources. From the pulpit should emanate gospel truths, not rank misstatements, calculated to deceive those who chance to hear. This is not civic uplift, but dangerous sophistries, they are unwittingly arranging to spread, and the harm they may do may retard seriously their sphere of usefulness in the cause of the Master. They are sowing the wind, and will surely reap the whirlwind for their folly.—Evening News.

You can always bank on preachers lineing up with any kind of a graft. Their business is graft and they live by trading on the future. If the Angel showed John a pure river, when he was finishing up his drunken revelry at Platmus, we may be sure that it was not the Owens River by any manner of means, or if it was the Owens River, John was still in the same condition that the Mayor and Committee were in, when they drank of it, during their late tour of the desert. Yes the fellow Brooks is no doubt a good sheepherder and wind sower—in fact that is all that any preacher is good for i. e., to make promises and threats of the future.

## SUPPOSE THEY TOLD THE TRUTH

An observing citizen says: "We hear a great deal of talk now on the street about the Owens River (?) water scheme. We hear it said the grafters who are pushing the scheme have no title to the water; they have not enough water; the water is Alkaline and unfit for use; the proposition is not feasable; the Aqueduct will fill with sand and be polluted with drowned animals, snakes and lizzards; it will take more than IO years to build it and it will cost several times \$23,000,000 to build it, etc.

Now the whole question to be decided is this; suppose they have title to all the Owens River (?) and Desert, suppose the title is good, suppose the water is the best in the world, suppose there was as much as there is in the Mississippi, suppose the scheme is feasable, suppose they cover the conduit all the way, suppose we never have another earthquake or sandstorm in Southern California and suppose they could build it in five years instead of 20, suppose it only cost \$30,000,000 instead of \$100,000,000, suppose it was not in the hands of a ring of thieves and there was no graft in it, suppose the bonds would sell if they were voted, suppose Otis was not a conceited liar and has sold out; is it a good business plan to mortgage our fair city to get money to buy and build what we do not want and have no use for and never will need?

It is stated that 22,300 miners' inches continuous flow of water is perculating down the Los Angeles River at W. Glendale.

Mulholland Lippincott and Eaton swore to it 11 years ago in a suit tried in our Los Angeles courts. The opposition to the Bonds have a transcript of this evidence. Now if this is a fact as they swore it was we have enough water for 2,000,000 people without any of the hundreds of artificial reservoirs which we could build. Why then go to the expense of holding an election to try to vote bonds to buy what we already have? We should have time to find out if we have this 22,300 inches which these great hydraulic engineers swore we have. The matter should be put in the hands of some honest men or women whom people could trust to tell the truth; men or women who have no graft at all in the matter. If we have all this water which they swore we have, then we do not need Owens Desert water at any price.

# OWEN DESERT POWER ALL TAKEN

Wilshires Magazine for May, describing an immense gold mine which Mr. Wilshire owns at Mt. Whitney says of the water power which the Owens Desert Bond thieves claim will make Los Angeles city the greatest city on Earth:

Combined with our enormous ore body, which stands out in plain sight for anyone to see, to sample, and to assay, is our tremendous water power, the falls of the Bishop Creek. Our engineers calculate this to be at least 10,000 horse power. We estimate that our water power alone is worth enou.) to pay a large interest to every investor in our stock, even if we never mined an ounce of gold. The Nevada Power Co., which owns the rights on the Bishop Creek immediately below our rights, has installed a plant which now supplies all the power for the great Goldfield and Tonopah mines in Nevada. This company cannot begin to supply the future demand for power which the mines will require, and in fact the present demand is far from being adequately met and, as a - consequence, the Nevada Power Co. is doubling its plant. That company is capitalized at \$5,000,000, and is paying handsome dividends. The stock is not on the market at any price.

For the further development of their power they have made an arrangement with the Bishop Creek Co. whereby the great lake—500 feet deep—immediately above our claims is to be dammed at an expense of \$200,000. This dam will regulate the flow of water. When the snow melts in August we have more water than we can use, and when cold weather comes in the autumn, we have less than we like.

When the dam is finished, the water in the creek will flow thru our property in a comparatively equal volume for the year, it will then pass thru our turbines, flow on and then be taken up by the Nevada Power Co. and pass thru their turbines, which are hundreds of feet below our mill sites. The whole of this expense of \$200,000 will be borne by the Nevada Power Co., and we will have just as much the full benefit thereof as if we had built the dam ourselves. It's really just the same as if the Nevada Power Co. should put \$200,000 in cash into our treasury without taking a penny in value in return for the gift. It's unnecessary to say that the Nevada Company is not a charitable institution, it is not giving us this \$200,000 because it wishes to boom our stock. It is doing so because it must regulate the stream, and the only place on the creek to do so is above us,, and therefore we, as a matter of course, are lucky enough to participate in the benefit of their work.

Orders were given to begin this dam last autumn and the Nevada

## PLENTY OF WATER AT HOME

"There are no reservoir sites to catch the storm water, and it is lost and is of no value to anyone except the lower lands between here and San Pedro, where it sinks and makes damp places."— Eaton's testimony.

Why go 250 miles away to impound the brackish run-off of a desert country, where the rainfall is only 3.58 inches, when we can store our own flood waters here at home—when we need them?

If the engineers named above are right—and they testified on oath—then 20,000 inches are available, after allowing for the flood waters, or run-off. The city utilizes about one-seventh this flow. It will be time enough to plan reservoirs to catch the runoff twenty years hence.

# A SPECIFIC STATEMENT

Statement of J. F. Holloway, for six years rancher in Owens River valley, who sold his Cottonwood creek rights (carrying 480 inches of water) to the city, and whose sister-in-law sold Haiwee reservoir site to the city:

"Owens River, of itself, is not fit for human beings to drink, as it runs through sixty or seventy miles of alkali swamps. Owens Valley, from Bishop to Little Lake, has all been a mineral lake at a previous time in its history, and all the land on either side is full of the alkali and soda. Every rain keeps washing this alkali and soda down to the river, and all the irrigating ditches continue to wash down the alkali and soda, and, the river taking it up, it is finally deposited in Owens Lake. Haiwee reservoir is the worst alkali basin in the whole valley. It gets the drain of all the upper valley and Owens Lake, being the lowest basin. I have seen, after a good rain, a lake of many acres of pure alkali water in Haiwee reservoir, so strong that no living thing would drink it. Just think of a human being drinking such filth!"

It would seem, or rather it does seem to me, that in all probability the center of one of these immense "neutral areas" would be so far removed from. every source of light in the whole universe as to be well described as "outer darkness." Should we believe that these are desolate wastes over which no sound ever wandered or no ray of light ever penciled an image? The answers to these questions are pressing for solution.
