What Silver Shirts Must Know about our Federal Reserve

AS A CURE for the national banking situation, President Roosevelt issued a ukase in April, under a usurped and unconstitutional power, declaring that all citizens who "hoarded" more than \$100 worth of gold after May 1st would be fined \$10,000 and sent to the Federal penitentiary.

Thousands of gullible citizens "fell" for this threat and poured what ready gold money they possessed, into the hands of voracious bankers, partly from an ignorant patriotic urge that they were doing it for the government, and partly from the fear of jail. *Now it appears that the whole thing was a piece of colossal bluff.* Having gathered in the shekels, there isn't to be any real persecution of those who have the courage to defy this dictatorial ukase.

Out in Colorado, former Senator Charles A. Thomas, waited until May 1st and then notified U. S. Attorney Ralph L. Carr, that he had acquired \$120 in gold—\$20 more than an individual may hold under the recent order of President Roosevelt. He thereby challenged the Federal government to prosecute him as a gold hoarder.

Will the Federal government do it?

Will Franklin D. Roosevelt submit his Stalin-like order to a test of the United States Courts?

He will not!

He is reported to have commented that "the \$20 overage wasn't worth conducting a trial about," and for the authorities to ignore the Colorado Senator's challenge.

This means in the eyes of the law that if such a ukase can thus be challenged successfully, the whole fiat amounts to nothing, since there is no arbitrary sum established for felony.

THE PURPOSES of the ukase, truth to tell, have been served. The major portion of the gold has been surrendered. Individual citizens have lost control of it, not to the Government at all, but to the privately owned Federal Reserve, largely under the control of Kuhn, Loeb & Company and its compatriot bankers.

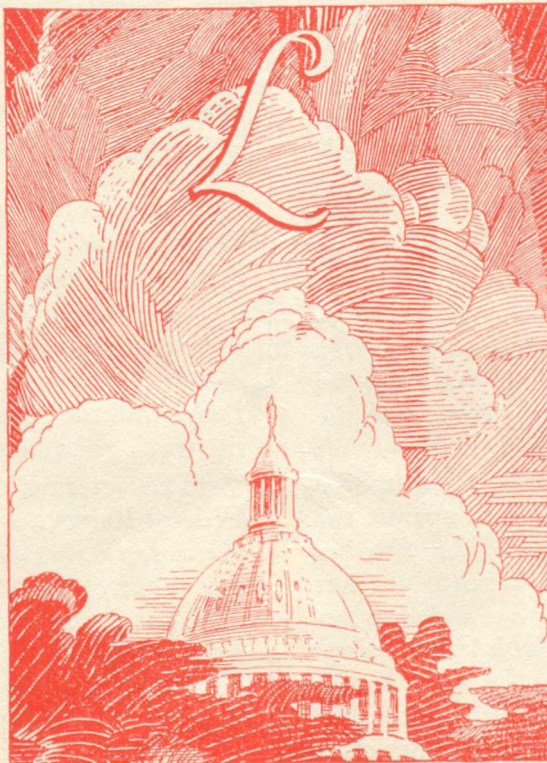

The Federal Loot Continues!

By the Hon. Louis T. McFadden

From the Congressional Record, May 4, 1933



MR. CHAIRMAN: *The United States is bankrupt! It has been bankrupted by the corrupt and dishonest Federal Reserve Board and the Federal Reserve banks. It has repudiated its debt to its own citizens. Its chief foreign creditor is Great Britain, and a British bailiff has been at the White House and British agents are in the United States Treasury making inventories and arranging terms of liquidation! . . .*

Mr. Chairman, the Federal Reserve Board has offered to collect the British claims in full from the American public by trickery and corruption, if Great Britain will help it to conceal its crimes. The British are shielding their agents, the Federal Reserve System, because they do not wish that system of robbery to be destroyed here. *They wish it to continue for their benefit!* By means of it Great Britain has become the financial mistress of the world. She has regained the position she occupied before the world war.

For several years she has been a silent partner in the business of the Federal Reserve Board and the Federal Reserve Banks. Under threats of blackmail, or by their bribery, or by their native treachery to the people of the United States, the officials in charge of the Federal Reserve Banks unwisely gave Great Britain immense gold loans running into hundreds of millions of dollars. *They did this against the law!* Those gold loans were not single transactions. They were revolving loans. They gave Great Britain a borrowing power in the United States of billions. She squeezed billions out of this country by means of her control of the Federal Reserve Board and the Federal Reserve banks.

AS SOON as the Hoover moratorium was announced . . . Great Britain moved to consolidate her gains. After the treacherous signing away of American rights at the 7-power conference at London in July, 1931, *which put the Federal Reserve System under the control of the Bank for International Settlements*, Great Britain began to tighten the hangman's noose around the neck of the United States.

She abandoned the gold standard and embarked upon a campaign of buying up the claims of foreigners against the Federal Reserve banks in all parts of the world. She has now sent her bailiff, Ramsey MacDonald, here to get her war debt to this country cancelled. *But she has a club in her hand! She has title to the gambling debts which the corrupt and dishonest Federal Reserve Board and the Federal Reserve banks incurred abroad.*

Ramsey MacDonald, the Labor Party deserter, has come

here to compel the President to sign on the dotted line, *and that is what Roosevelt is about to do!* Roosevelt will endeavor to conceal the nature of his action from the American people. But he will obey the international bankers and transfer the war debt that Great Britain should pay to the American people to the shoulders of the American taxpayers.

Mr. Chairman, the bank holidays in the several States were brought about by the corrupt and dishonest Federal Reserve Board and the Federal Reserve banks. Those institutions manipulated money and credit, and caused the States to order bank holidays.

Those holidays were frame-ups!

They were dress rehearsals for the national-bank holiday which Franklin D. Roosevelt promised Sir Ronald Lindsay that he would declare.

There was no national emergency here when Franklin D. Roosevelt took office *excepting the bankruptcy of the Federal Reserve Board and the Federal Reserve banks!*—a bankruptcy which has been going on under cover for several years and which has been concealed from the people so that the people would continue to permit their bank deposits and their bank reserves and their gold and the funds of the United States Treasury to be impounded in these bankrupt institutions.

Under cover, the predatory international bankers have been stealthily transferring the burden of the Federal Reserve debts to the people's Treasury and to the people themselves. They have been using the farms and the homes of the United States to pay for their thievery! *That is the only national emergency that there has been here since the Depression began.*

SOMEONE asked Mr. Ogden Mills what caused the depression. He answered quite truthfully: "The Federal Reserve loaned so much money abroad that it broke down the system."

Mr. Chairman, those who have lost everything they possessed through the evil practices of the Federal Reserve Board and the Federal Reserve banks should at least be told the truth as to how it happened.

The veterans of the World War should know that the Federal Reserve Board and the Federal Reserve banks *paid the dole in England and are still paying it*, and that is the reason why the resident agents of England in this country have cut the pensions of the United States soldiers 400 millions of dollars a year!

The week before the bank holiday was declared in New York State, the deposits in the New York savings banks were greater than the withdrawals. There were no runs on New

York banks. There was no need of a bank holiday in New York, or of a national holiday.

Roosevelt did what the international bankers ordered him to do!

When Sir Ronald Lindsay was at Warm Springs, Ga., when Franklin D. Roosevelt violated the Logan Act (which makes it a crime for a private citizen to transact the public business with agents of another nation) the obnoxious Lindsay was promised that the United States would be taken off the gold standard "without debate" and "by surprise" and that was what England wanted, and was insisting upon.

Sir Ronald Lindsay hotfooted it to London to tell the good news to the English Cabinet. (For the Jewish composition and domination of this Cabinet see details in ensuing article—Ed). They did not trust the mails nor their favorite instrument, the trans-Atlantic telephone.

Do not deceive yourself, Mr. Chairman, or permit yourself to be deceived by others into the belief that Roosevelt's dictatorship is in any way intended to benefit the people of the United States; he is preparing to sign on the dotted line.

He is preparing to cancel the war debts by fraud!

He is preparing to internationalize this country and to destroy our Constitution itself in order to keep the Federal Reserve Board and the Federal Reserve banks intact as a money-saving institution for foreigners!

MR. CHAIRMAN, I have received an inquiry from one of my constituents in regard to his right to have gold and gold certificates, silver and silver certificates, and all other forms of coin and currency issued by the United States Government in his personal possession, or in the possession of his agents. Mr. Chairman, I have informed my constituent that he has a constitutional right to have gold and silver in his possession, either in the form of bullion or of coin, and that he has the right to have United States currency of every description in his possession, and that his right to hold such private property is absolute and that such private property may not be taken away from him without due process of law.

Mr. Chairman, I see no reason why citizens of the United States should be terrorized into surrendering their property to the international bankers who own and control the Federal Reserve Board and the Federal Reserve banks. The statement that gold would be taken from its lawful owners if they did not voluntarily surrender it, to private interests, shows that there is an anarchist in our government!

The statement that it is necessary for the people to give their gold—the only real money—to the banks in order to protect the currency, is a statement of calculated dishonesty!

By his unlawful usurpation of power on the night of March 5, 1933, and by his proclamation, which in my opinion was in violation of the Constitution of the United States, Roosevelt divorced the currency of the United States from gold, and United States currency is no longer protected by gold. It is therefore sheer dishonesty to say that the people's gold is needed to protect the currency.

Roosevelt ordered the people to give their gold to private interests—that is, to banks—and he took control of the banks so that all the gold and gold values in them, or given

in to them, might be handed over to the predatory international bankers who own and control the Federal Reserve Board and the Federal Reserve banks.

Roosevelt cast in his lot with the usurers.

He agreed to save the corrupt and dishonest Federal Reserve Board, and the Federal Reserve banks, at the expense of the people of the United States.

He took advantage of the people's confusion and weariness, and spread a dragnet over the United States to capture everything of value that was left in it. He made a great haul for the international bankers.

Mr. Chairman, the terms of Mr. Roosevelt's surrender were arranged between himself, certain "international bankers," and Sir Ronald Lindsay. A British paper has lately said that Roosevelt refrained from accepting responsibility before he acquired authority in all matters *except the matter of the war debts.*

So you see, Mr. Chairman, before entering the presidency he took up the matter of the war debts. He violated the terms of the Logan Act.

Mr. Chairman, statements in the newspapers to the effect that the conferences now taking place are mere academic and preparatory discussions between officials of the United States government and representatives of foreign nations, are false!

The Prime Minister of England came here for money! He came here to collect cash.

He came here with Federal Reserve currency and other claims against the Federal Reserve system which England had bought up in all parts of the world, and he has presented them for redemption in gold.

Mr. Chairman, I am in favor of compelling the Federal Reserve Board and the Federal Reserve banks to pay their own debts. I see no reason why the general public should be forced to pay the gambling debts of the international bankers.

By his action in closing the banks of the United States Roosevelt seized the gold value of the 40 billions and more of bank deposits in the United States banks. Those deposits were deposits of gold values. By his action he has rendered them payable to the depositors in paper money only, if payable at all, and the paper money he proposes to pay out to bank depositors and to the people generally in lieu of their hard earned gold values is of no intrinsic value in itself and, being based on *nothing into which the people can convert it*, the said paper money is of negligible value altogether.

It is paper money which is not convertible into gold or silver. It is money of slaves, not of free men. If the people of the United States permit it to be imposed upon them at the will of their credit masters, the next step in their downward progress will be their acceptance of orders on company stores for what they eat and wear. Their case will be similar to that of starving coal miners. They too will be paid with orders on company stores for food and clothing, both of indifferent quality and be forced to live in company-owned houses from which they may be evicted at the drop of a hat. More of them will be forced into conscript labor camps under supervision.

At noon on the 4th of March, 1933, Franklin Delano Roosevelt, with his hand on the Bible, took an oath to preserve, protect, and defend the Constitution of the United



States. At midnight on the 5th of March, 1933, he confiscated the property of American citizens. He took the currency of the United States off the gold standard of value. *He repudiated the internal debt of the government to its own citizens!* He destroyed the value of the American dollar. He released, or endeavored to release, the Federal Reserve banks from their contractual liability to redeem Federal Reserve currency in gold or lawful money on a parity with gold. He depreciated the value of the national currency.

The people of the United States are now using unredeemable paper slips for money. The Treasury cannot redeem that paper in gold or silver. The gold and silver of the Treasury has unlawfully been given to the corrupt and dishonest Federal Reserve Board and the Federal Reserve banks. And the Administration has since had the effrontery to raid the country for more gold for the private interests by telling our patriotic citizens that their gold is needed to protect the currency.

It is not being used to protect the currency! It is being used to protect the corrupt and dishonest Federal Reserve Board and the Federal Reserve banks!

The directors of these institutions have committed criminal offense against the United States Government, *including the offense of making false entries on their books, and the still more serious offense of unlawfully abstracting funds from the United States Treasury!*

Roosevelt's gold raid is intended to help them out of the pit they dug for themselves when they gambled away the wealth and savings of the American people.

THE INTERNATIONAL bankers set up a dictatorship here because they wanted a dictator who would protect them. They wanted a dictator who would issue a proclamation giving the Federal Reserve Board and the Federal Reserve banks an absolute and unconditional release from their contractual liability to redeem their special currency in gold,

or lawful money at any Federal Reserve bank.

Has Roosevelt released any other class of debtors in this country from the necessity of paying their debts? Has he made a proclamation telling the farmers that they need not pay their mortgages? Has he made a proclamation to the effect that mothers of starving children need not pay their milk bills? Has he made a proclamation relieving householders from the necessity of paying rent?

Not he! He has issued one kind of proclamation only, and that is a proclamation to relieve international bankers and the foreign debtors of the United States Government.

MR. CHAIRMAN, the gold in the banks of this country belongs to the American people who have paper money contracts for it in the form of national currency. If the Federal Reserve banks cannot keep their contracts with United States citizens to redeem their paper money in gold, or lawful money, then the Federal Reserve banks must be taken over by the United States Government *and their officers must be put on trial.*

There must be a day of reckoning. If the Federal Reserve banks have looted the treasury so that the Treasury cannot redeem the United States currency for which it is liable in gold, then the Federal Reserve banks must be driven out of the Treasury.

Mr. Chairman, a gold certificate is a warehouse receipt for gold in the Treasury, and the man who has a gold certificate is the actual owner of a corresponding amount of gold stored in the Treasury and subject to his order.

As Charles N. Fowler, a former member of this House, said when he was chairman of the House Banking and Currency Committee: "A gold certificate is its own redeemer."

Now comes Roosevelt, who seeks to render the money of the United States worthless by unlawfully proclaiming that it may NOT be converted into gold at the will of the holder.

Is this Truth or Fabrication ?

THE CHOICE morsel below is being circulated over the United States by private letter-chain. The copies received at this office are marked: Printed in Banker's Manifesto, Banker's Magazine, intended for private circulation only. Taken from Civil Servants' Year Book, The Organizer, January, 1933.

"Capital must protect itself in every possible way, through combination and legislation. Debts must be collected and loans and mortgages foreclosed as quickly as possible. When through a process of law the common people have lost their homes they will be more tractable and more easily governed through the strong arm of the law applied by the Central power of wealth under the control of leading financiers. People without homes will not quarrel with their leaders. History repeats itself in regular cycles. This is well known amongst our principal men now engaged in forming an imperialism of Capital to govern the world. By dividing the voters we can get them to expend their energies in fighting over questions of no importance to us except as teachers of the common herd, thus by discreet action we can secure for ourselves what has been generously planned and successfully accomplished."

What Does Mr. McFadden Mean by "Great Britain?"



WHEN the Hon. Louis T. McFadden in his great speech of May 4th in Congress—*wholly ignored by all the newspapers you will observe!*—spoke of "Great Britain" putting a bailiff in our United States Treasury, making inventories of our assets by Franklin D. Roosevelt's connivance and consent, *he by no means meant the English people!*

When Sir Ronald Lindsay got our President's promise that he would take the United States off the gold standard "without debate" and "by surprise," and Lindsay hotfooted it to London to tell the good news to the British Cabinet, he by no means went to report to the rank and file of our British blood-cousins. As a matter of fact, the British Cabinet does not represent the English people as Christian Anglo-Saxons. Our British cousins have lost control of their own Empire, exactly as we have lost control of our government here in the United States.

A "curious fact"—and yet not so curious—dominates the situation in Great Britain. For some years a group of financiers whose families for the most part are of German-Jewish origin, has assumed control of the political and financial power in Merrie England, and is making Great Britain play the part of Shylock toward the United States.

THE Monds, Sassoons, Rufus Isaacs—those known as the representatives of the "international banking interests"—as Mr. McFadden has put it, dominate the British Empire, own its newspapers, control its elections, and direct the affairs of the Bank of England.

The close solidarity existing between Mr. Lloyd George and Jewish high finance is easily shown by the brief biological sketches of some of the influential personages by whom England's Prime Ministers are constantly surrounded.

In the first place, Mr. Ramsey MacDonald is responsibly alleged to have had a Jewish mother, making him a half-Jew and explaining his strange stability through the vicissitudes of British politics.

Mr. MacDonald has as his closest confidential secretary one Rose Rosenberg, an arrogant little Jewess who openly brags that *she* runs the British Empire, in that no one will see the Prime Minister for any reason whatsoever unless she approves, and knows what the business is in advance. Rose, according to under-cover agents, is the official representative—we might even say spy—for the international organization of Ash'kanazim Hebrews whose headquarters have been in Germany before the Hitler ousting.

Christian members of Congress have conducted some interesting investigations to place whether or not Miss Rose

Rosenberg was the third party sitting on that log on the Rapidan when MacDonald and Hoover had their memorable conversation . . .

THE JEWISH "shadow" on Stanley Baldwin was one Goldringham, whose intimate tie-up with *Arcos*, the British-Soviet *Amtorg*, was definitely proven under the most malodorous circumstances.

When Lloyd George was Prime Minister, he had for a "secretary" Sr. Philip Sassoon. The British Cabinet contained, and contains, such outstanding members of Ash'kanazim Jewry as Lord Reading—real name Rufus Isaacs—member of the Privy Council, and Viceroy of India; also Lord Montagu—Edward Samuel Montagu—member of the Privy Council, holding a Minister's Portfolio with the present government and in dominating command of the Bank of England, now attempting with Roosevelt's assent and connivance to be the official pawnbroker to the United States.

"Each of these names," says Andre Cheradame, "represents not only an eminently prominent individual, but also the veritable chief of a tribe, and head of immense financial Jewish interests.

"Sir Philip Albert Gustav David Sassoon, whose famous estate of Lympe is so frequently used as a meeting-place by the Supreme Council, is the son of Sir Edward Sassoon, one of the richest financiers in the world. On his mother's side he is a grandson of Baron Gustav de Rothchild, although the Sassoons are Asiatic Jews, coming originally from Bagdad.

"Sir Philip Sassoon and his cousin D. R. Sassoon, are at the head of the banking house of David Sassoon & Company. He is likewise closely related to Sir Jacob Elias Sassoon, head of the firm of E. D. Sassoon & Company, one of the most powerful commercial and financial establishments in India and the Far East, and is a near relative of a score of other Sassoons in England and India.

"The House of Sassoon, with all its affiliations and ramifications, is considered from a financial standpoint as holding the same position in Asia that the House of Rothchild holds in Europe.

"Lord Reading, or Rufus Daniel Isaacs as you prefer, member of the Privy Council, former Attorney-General, ex-Minister of Justice, is now Viceroy of India. Toward the close of the war, Lord Reading was sent as High Commissioner and Ambassador Extraordinary from Great Britain to the United States. As such he possessed tremendous influence with President Wilson and his intimate associates, (Baruch and Warburg?) among whom were a great number of Jews. An intimate friend of Lloyd George, Lord Reading is now one of the leading men in English public life. He belongs to the world of Jewish high finance that has

bankrupted America, and according to *The Congressional Record* is now using Franklin D. Roosevelt as a tool and dupe to make the loot good.

"In this world of Jewish high finance, his two brothers play important parts. One of them, Godfrey Charles Isaacs, is general manager of all the Marconi Companies and could justly lay claim to the title The Wireless King. Thus are the transatlantic communication systems subject to "certain censorships" on correspondents, so to speak. The other brother, Harry M. Isaacs, manages and controls the British Cellulose & Chemical Manufacturing Company, the largest makers of chemical products in England.

"THE SAMUELS constitute a vast tribe, exceedingly numerous, influential, and complex. Besides two of Mr. Lloyd George's intimate associates—Lord Edwin Samuel Montagu, member of the Privy Council and Secretary of State for India (the British Foreign Office in short) and Sir Herbert Samuel, Viceroy of Palestine, where the Dead Sea is located with enough potash and mineral deposits to pay off the combined national debt of both America and England, there is a host of other Samuels belonging to the world of Jewish high finance.

For instance, there is Sir Harry Samuel, who controls the Shell Transport and Trading Company, and the Anglo-Saxon Petroleum, as well as the Royal Dutch Company, the Mexican Eagle Company, and the Balaafsche Petroleum Maatchaooij.

"Last comes Sir Alfred Mond, member of the Privy Council, minister in British Cabinets, and head of the Economic Council in the Zionist Movement. This man, the son of a naturalized German, is one of the nickel kings, the supreme master of international commerce in chemical products, and proprietor of the *Westminister Gazette*. Sir Alfred's daughter married the son of Lord Reading—or Rufus Isaacs as you prefer—Viceroy of India.

Shades of Henry II, Oliver Cromwell, William Pitt, and Sir Francis Drake! As W. Hughes the great Premier of Australia exclaimed: "What is the good of being a wealthy nation, if the wealth is all in the hands of German Jews?"

THIS is the race and the clique to which Louis T. McFadden refers when he tells of Sir Ronald Lindsay hotfooting it home to London to report to the "British Cabinet." Such is the alien oligarchy that has the cool effrontery to send an agent into our United States Treasury to inventory our assets (what we have left that they have not already taken) or that purport to have extracted a promise from our "new" President that he will shove the United States off the gold standard "without debate" and "by surprise!"

Fine terms for employment in the august office dignified by such men as George Washington, Thomas Jefferson, Andrew Jackson, and Abraham Lincoln! Something that Franklin D. failed to tell us over the radio!

With the dubious practices of the recent President Hoover in mind, our citizens cry despairingly: "But is there no one we can trust? Are all men in public life 'sold out' to those Jewish internationalists?"

The answer is a thunderous "YES!"

You are not permitted to hear of men who will not do the bidding of these foreign oligarchs with their numerous breed scurrying like weasels throughout every cranny of our Christian institutions.

The press is ordered to "lay off" all others and give them no publicity, under threat of having their department-store advertising taken away from them. They cannot get publicity on the movie screen or in the news weeklies, because it was to block exactly that which brought about a 100 percent Hebrew control of Hollywood. The radio too has its Jewish czars who give their approval or disapproval as to who shall enjoy the Air.

The only time that a man gets publicity who is not a "front" for their international strategies is when a leader like Hitler "uses an iron wedge and splits a hardwood block." Then these great inventions are turned on full blast to villify and destroy him. Or a Jewish columnist like Walter Winchell, secure from Nazi reprisals far over here in America, starts a story about Hitler being a "pansy," a homosexualist—the filthiest sort of scurrility that can be indulged in.

If Franklin D. Roosevelt had not been acquiescent to these alien money kings and their satraps from abroad, he never would have "gotten a smell" of the American Presidency. He never would have gotten a "smell" of the New York governorship—where a Jew, Lehmann, now sits enthroned in his place, just as the half-Jew Alfred Schmidt, popularly known as Al Smith, sat before him—and where one Martha Markowitz was his privy adviser.

Two years ago *Liberation* made some statements that at that time were resented, about the background and "controls" of one Herbert C. Hoover. A howl of rage went up for an alleged villifying of "the grand and glorious office of the United States Presidency." But those people who took *Liberation* to hand then, have since met with disillusion. They are not howling in rage now. They are coming back and admitting we knew our

facts, and throwing their strength squarely and grimly behind the *Silver Shirt* Movement in America, to "split a hardwood block" here exactly as Hitler has split it in Germany.

For clairvoyants of sober repute tell us that it is only a question of time when the American and English people are both going to arise simultaneously and clean their Christian governments and Christian households from those whom Congressman McFadden has fearlessly castigated as thieves, looters, and international scoundrels.

The nation is *not* looking with favor and approval on these Jewish-protest parades being staged under the pressure of a great fear, in our large American cities.

Again we say, there is neither rancor or race prejudice in the battlecry of the Silver Shirt Christian Militia: "*America for its Christian Americans!*" Our forefathers founded this nation. It is our homeland. We have fought for it. We love it. It happens to be a Christian country, even if only nominally. We intend it shall continue as such, and no predatory Asiatic horde from overseas shall first bankrupt us, and then treat us contemptuously in our own treasure house.

But there can be no rebirth until America, like Germany, has undergone its bath of soap suds!

2 Every man hath a birthright: it cometh to him as knowledge of his purpose for being in life; it is his treasure and his heritage; it goeth not from him though mountains arise or deep seas engulf him.

3 I say to you, ye have a treasure: it is your capacity to perform, to render goodly accounting to the Father for the labor which he hath given unto your

hands to perform.

4 I say, go not forth until it be evident to you that the times mature for positive action; trust not to your senses if they call you to those parts which hold no offering of ready action for you;

5 Seek out no brethren who do not say: We perceive that if ye do come among us we can uphold your hands the better for service;

6 Make no untoward move toward battlement that hath not its promise of success from tumult;

7 Give fortune no hostages by asking this one or that one if it pleaseth him to be of service.

8 Open your hearts to those agencies that do come voluntarily and offer you a competence of labor expended if ye expend your own.

9 I say to you times come upon this nation when the storm which now bloweth is but a shuttlecock to the tempest which rageth presently: the rich go down, the mighty rise up; those who have the sign upon their foreheads arise and take command.

10 I say it is a sign and a promise that ye have friends who do uphold your hands, but give yourselves no surcease in endeavor that ye attend to their beguilings of your interest in their behalf.

11 Hold fast to that which is true and right; keep a steady eye and arm for the nerve-and-sinew expending which draweth nigh unto you; give a firm forecast of that which happeneth *and know your heritage*.

12 Take a mighty aim at evil and draw a sturdy arrow; aim straight, aim true, deliver the blow, mock not the adversary with vauntings but deal him his body blow with an arm which fainteth not.

13 But not yet, beloved: sufficient unto the day is the struggle thereof.

14 Prepare yourselves: be prepared; give a goodly competence to sorrow as it beseecheth you, but make not the error of finding yourselves without weapons in a land that is strange.

15 Take your inheritance of leadership: exercise it: give it pulse and sinew; the times draw on swiftly wherefore ye were prepared over many months of discourse; quail not before them but arise sturdily and execute your earthly in-

heritance of ministering in my name and for my glory among the sons of worldly men.

17 Truly they shall see your good works and glorify him who sent you among them.

19 Give your advice as a general directeth his army from his tent: he seeth not the battle: he fireth not his weapons: he giveth no card to endurance: for that was he made commander, that he taketh his counsel with himself and sayeth: That shall be done, go thou and execute it; and to another, Stay until I bid thee ride.

Why America is Called to Suffer this Turmoil . .

DO NOT let anyone corrode your reasoning powers into the acceptance that all of your present diablerie is a matter of chance, on any planes whatsoever.

Chance does not enter into what is happening now.

There has been a steady tendency of late years for the people themselves to pay less and less attention to the affairs of government, let anyone run them, accept any sort of fraudulent officialdom that happens to win out of its own volition or those of hired organizers at the ballot box, and generally get along as best it may in its public affairs while the average citizen applies his uninterrupted efforts to making money.

It is a perfectly silly and infantile view for the average citizen to take, seeing that in the long run all that he earns or wins by such selfish application is ultimately taken from him by those predatory officers who have ensconced themselves in power.

Nevertheless, it is a business which the average citizen must learn.

He must be taught by having a visual demonstration before his eyes, that if he elects to apply himself to his private affairs to the detriment of his public interests, he is going to lose out all along the line. If he will be so foolish as to close his eyes to crooked officialdom, he must be the one to suffer for the blunders of this crime against his own pocket-book.

THERE is no such thing as any country running itself. All countries get exactly the types of government they deserve, the same as a man usually gets the type of matrimony which he either solicits by his behavior at home, or which he bargains for by the kind of husband he is in his own private actions, at home or otherwise. The government of a country is the active criterion of the temperamental responsibilities of the average citizen. And if a government becomes encrusted with human barnacles, if it becomes archaic, unwholesome to the people's nostrils, and a thing of lechery and venalty, it is nobody's fault but the average citizen's. *He doesn't have to put up with it one day longer than he actually approves of it—if he will translate his disapproval into action.* That is, in the taking of an active part in public affairs instead of leaving them to others.

Today, or up to the present time, the average citizen has said, "I haven't time," or "Public affairs do not arouse the interest in me that my private business does," and he has gone

his way, leaving public affairs to the demagogues and self-seekers in office. Now Mr. Average Man is being called upon to pay, and he will pay, through the nose, make no mistake about it.

Things in America are at this pass, and true leadership is being denied the American people because God Almighty wishes the masses themselves to realize the terrific corrective powers they have in their own hands, and compel them to use such powers, not delegate them over and over to scoundrels and then wonder why the government is a continual miasma of crime and wrong.

There is no way out of this morass other than by the average citizen making it his business, as an individual, to see that the public's business is run in the interest of the public and not in the interest of a few blackguards at the head of affairs simply because they have been clever enough to get themselves elected there. The average man has got to personally evaluate these ideals and virtues which made the beginnings of his country auspicious, but which have now become subverted and traduced to suit the purposes of every nation on earth but America herself.

This can be done with small suffering to the individual if he will only awaken to the responsibilities devolving upon him as a basic unit in the body politic and not leave all such "unpleasant business" as government to his neighbor or his neighbor's daughter's ex-husband, who is out of a job and therefore essays to tackle the public business, having failed in his own.

THE TIME has arrived when Americans must learn this mighty lesson and no nonsense about it. God Almighty, we say, could raise up leaders in this crisis who could snatch the nation out of your doldrums in sixty days, figuratively speaking. But nothing of the sort is being permitted, as you observe to your despair and confusion. The process at work is one of selective citizenship and statesmanship. The necessity has arisen for the average man to realize that the responsibilities of statesmanship devolve upon himself and none other, that he is not a pawn of politics but the master of politics, that he is not called upon to submit to officialdom that he knows to be crooked but that if he submits to its lecheries it is because he is lazy, indolent, and deserves exactly the crooked deal that comes to him.

We cannot stress all this too strongly. America can never come out of her doldrums by talking about them or waiting for the new Moses of the times to appear. He is being held back forcibly, so to speak, until the average citizen learns his lesson and learns it well. Men must be made to *feel*—in the literal sense of the word—that citizenship is a sacred

thing, carrying sacred responsibilities, not something to be trafficked in and bruited about to the highest bidder in election promises. When he learns that lesson, or gets it into his consciousness, the times will begin to change. But they will only change as the average man dictates that they shall be changed because he goes to work and changes them by the means and powers that right at this moment are directly in his hands.

WE OF the Higher Planes of Consciousness have been striving through our earthly brethren of psychic attainments to bring these truths to a few of you, comparatively speaking, that you might pass them on to the troubled individual who has lately been mulcted of all he cherished most. Your hapless friend has lost all he once prized and cherished because he was short-sighted in his logical discernments. He deserved to lose because he never exerted himself to figure out what would happen to him if he did not protect himself from the predatory tactics of rascals who might steal upon him and snatch his possessions in that he did nothing to curb their growing rapacities.

Those people who have lost, have only themselves to blame in this regard. They have known that great rascals were ensconced in high places. They have more or less cheerfully tolerated such humbuggeries. They have gone on from day to day and year to year, admitting that the tariff for public rascality was growing increasingly heavier, but on the whole accepting it good naturedly as one of the penalties of living in a world of fallible human nature.

Now nothing of the sort was the true order of the moment. What banker would be fool enough to resign or hand over the keys of his bank to a set of burglars, and what sympathy would you have for that banker who wailed at a later date that such depredatory rascals had gutted the institution and lost such a banker his fortune? You would say to him: "Well, and who have you to blame but yourself? God gave you sense. You knew the persons you left in your place to run the affairs of your bank were thieves. Yet knowing this, tolerating it, thinking that letting thieves into such positions of trust was part of the tariff of living among fallible human nature, you are now protesting tearfully, or caterwauling obscenely, that you have been looted. Is that sense? Is that logic? If you left thieves to run your bank and they have looted it, stand up to your losses like a consistent individual. There is no one to blame for your absurd conduct and its unfortunate results in losses, but yourself."

THIS is exactly the way that we of the higher dimensions feel about those of you who have suffered terrific losses, even of your life savings, without in the slightest wishing to be less your friends or appear calloused. We are anything but calloused. But you have tolerated, acknowledged and confessed thieves in the bank of your public affairs, and you think God is very harsh because He let them loot you of everything you possessed.

To date, however, you have only lost your money or your property. The next loss which

is coming upon you in like tenor is the loss of your liberty of person and directing voice in your political affairs. You are fairly shouting for some sort of dictator, who will make your nation a prison house and say literally when you shall go and come and what time you shall be in off the streets at night. Undoubtedly when you have let this be accomplished as well, you will turn on God and think that He is equally as harsh. *But you will not learn that all the time you have the means for casting off this lecherous load of encroachments on your properties and liberties, by the simple expedient of the freeman's ballot.*

You are like a lot of noisy school children, warned again and again if you go on with your personal mischiefs that you will be trounced, but relying on your personal cleverness to ultimately talk the teacher out of the trouncing. But you are not clever at all, else you would obey the signs of the times, realize your predicaments with increasing force, and make the heroic effort to help yourselves.

You can drive out any rascals in the land, out of any positions they hold whatsoever, by simply acting with your fellow citizens and putting honest men in their places. But you will not do this. "Leadership must arise" you say, first. In other words, the old, old cry, "Let someone else do it, we are too busy."

You are too busy to protect your own interests, therefore you must enjoy the suffering you are undergoing. Very well, we say in all kindness to you, continue to suffer until you come to your senses and make your own gestures to rid yourselves of your pestilence.

There is no other way out. When you make this effort, of your own free will and volition, you will observe leaders released to aid you in so doing whose power and dynamic potentialities for pointing a way from the morass, will astound you. But the first gesture is up to you. You can so register your disapproval of what is going on at present in your legislatures, as to frighten these political demagogues out of their wits. But if anyone proposes such action, you will probably react in the same old way, declaring: "Reform movements never get anywhere, they never last, so what's the use of starting another one?"

The fact is, that reform movements do not last because even good people are politically lazy and will not allow that eternal vigilance is the price of liberty, even political and economic freedom from lechery, in this world, the same as anything else. Protect yourself and you are protected; let yourself be laid open to evil influences through your own indifference, and rest assured you are going to be taken for a longer ride than ever given to a Chicago millionaire mobster by Chicago gangsters.

It is all up to you, we say again.

We have the men in reserve. We have the Plan in reserve. We in these Higher Dimensions know exactly what to do to help you rid yourselves of your pestilence. But *when* you want to be rid of it is strictly up to you.

Until then, our patience is quite as good as your indolence.

But the Penny Bounces!



WHEN I was a little shaver of about five, my greatest joy was "to go visiting" at Gran'ma's in the country. Vividly down the long stretch of years comes the picture of that wee weather-beaten house, perched upon the steep slope of a New England rocky hillside.

Two strangely different things in that old Methodist home left their indelible impress upon my plastic mind; sugar cookies and the big, old family Bible!

In a cool pantry was a vast stone jar with a wealth of luscious crisp, crunchy cookies, encrusted with glittering sugar crystals that gave a royal setting for the big fat raisin that topped each one. By the rag-carpet loom in the "sittin' room" was the Bible—and what a noble book it was! An enormous tome, its heavy covers embossed in gilt, with its records of Births, Marriages and Deaths, and scores upon scores of pictures vividly portraying the lives and deeds of the Holy ones who walked and talked with God.

One picture in particular stamped itself upon my child-mind, never to be erased. Over in the Old Testament, in First Samuel, was the story of David and Goliath. Long before I learned to spell out the word-story of how the diminutive David slayed the giant Philistine Goliath, it had been imparted to me by the gory picture, explained by Gran'ma, showing David with foot upon the prostrate giant, whose head had been deftly severed with his own sword.

There always has been a magic fascination about that story of David, discarding the armour and the sword that had not been proven, taking his simple sling and the five smooth stones, and *going out to meet* the giant enemy.

"And it came to pass, when the Philistine arose, and came and drew nigh to meet David, that David *hasted*, and *ran* to meet the Philistine. And David put his hand into his bag, and took thence a stone, and slang it, and smote the Philistine in his forehead, that the stone sunk into his forehead; and he fell upon his face to the earth. So David prevailed over the Philistine with a sling and a stone . . . but there was no sword in the hand of David. Therefore David ran, and stood upon the Philistine, and took *his* sword, and drew it out of the sheath, and slew him, and cut off his head therewith."

Today, in Liberation, we have a modern counterpart of that Old Testament tale. Like David, Liberation "*hastes*" to meet the giant enemy—the current model of Goliath—the 1933 Philistine that would despoil our country, our homes and our people.

Our David *hastes* to meet his Goliath. He has the sling of courage, *but the bag yields no lethal smooth stones with which to penetrate the forehead of the enemy.*

All the bag yields is a penny, and when it is *slung* it but bounces off Goliath's forehead.

Courage *to attack* is not lacking.

Eagerness *to run to meet* the present Philistines is not lacking.

Love and loyalty to God and Country are not lacking. *But the penny bounces!*

All that is lacking for this modern David of Liberation to successfully carry the battle to Goliath is *heavy enough* stones and a *sufficient supply* of them.

Instead of Liberation having to figuratively and actually "pass the hat" constantly, there should be a steady stream of modern "smooth stones" being freely and willingly sent its way.

There are thousands upon thousands who still have ample funds against which they might check to enable Liberation to blast effectually into the fast-advancing ranks of the red Philistine horde, but most of the richer men and women have writer's cramp. They are blind to the danger which TODAY is racing to wipe out their property, their wealth, yes, their very lives.

If only as a new form of life insurance, as protection against the despoiling of their homes and loved ones, all who have an Hundred, or a Thousand, or Ten Thousand Dollars can find no better use for it than putting it at the disposal of LIBERATION to back its fight for God and Home and America!
