



INTRODUCTION.

Few institutions of the present time have attained the recognition which is so freely given to the Weltmer Institute. Any college which acquires such prestige does so not only because it has created a demand for its work, but because it fully responds to and supplies the demand. The purpose of the Weltmer Institute is to promote physical and mental health, and it fulfills that purpose by co-operation with nature's finer forces. The founder of the Weltmer Institute, Prof. S. A. Weltmer, has made a life long study of the different healing methods and the result of his investigation is imparted to the students of his school. In its several different departments are taught and practiced healing on all planes, physical, mental and spiritual, and especial attention is given to the elementary principals of natural and abundant health, and strength on those lines.



PERSONAL TREATMENT.

First in importance of the departments of the Weltmer Institute is that of Personal Treatment. Upon the success of this department rests the undisputed right of the Weltmer Institute to the title of the Greatest School of Drugless Healing in existence. Its record of 100,000 healed patients is almost double that of any other one school. This wonderful success is due entirely to the natural simplicity, and absolute certainty with which the fundamental laws underlying Mr. Weltmer's science, operates.

The patient is not confused by being told that his malady is unlike any other case known. He is told plainly what co-operation will be demanded on his part. He is not required to take a long, tedious course of exercise, diet or baths, but in passing we will say that the Institute recognizes the benefits to be derived in particular cases from consistent exercise and regular baths accompanied by physical manipulation and massage and when necessary these things are prescribed.

Patients who enter the Weltmer Institute become quite unconventional. Social dissipation and display are entirely absent. Every one is made akin through the honest, earnest work for health. New patients enter at once into the home like atmosphere. The fact that every one is getting well creates a friendly rivalry which spurs all to their best efforts. The patient is at once started on the Weltmer way to health—nature's way.

Prof. Weltmer's treatment is a veritable proof of the cell theory. It treats of the cell and the atom in its relation to the man. Briefly,—the cell theory is that all physical structure is composed of cells vibrating at a certain rate. If the normal rate of vibration is disturbed a morbid condition is the result. The nervous system is the interpreter of sensation and conveys to the brain the intelligence of morbid vibration whenever it occurs. By many experiments Prof. Weltmer found that the natural vibration of a healthy person could be transmitted to the body of a diseased person through the well trained hand thus establishing a normal vibration and restoring to the weakened organs their natural functions. The treatment awakens the regenerative forces lying dormant in the patient and utilizes these forces in the restoration of weakened and deranged structures.

The source of nearly all disease is ignorance, and it is the purpose of this treatment to enlighten the patient with a knowledge of the laws governing health. That this co-operation between mind and body to restore health is the logical way out of disease, is easily proven by the

astonishing record mentioned above,—100,000 cures to the credit of the Weltmer method in ten years.

COURSE OF STUDY.

In outlining the Course of Study in Drugless Healing, taught and practiced in the Weltmer Institute, it is necessary to divide the description in five parts;

(I) PROF. WELTMER'S SCIENCE OF DRUGLESS HEALING.

This branch of study is the center around which all the other branches cluster. Anatomy, physiology and pathology are taught as they assist the application of this fundamental subject.

As a teacher Prof. Weltmer stands among the first, and presents his philosophy in a manner so clear and distinct that his meaning cannot be lost. He knows better than any other how to teach the principles of the science he has founded, and each member of his faculty is not only under his personal training, but is chosen for his perfect understanding and ability to teach this science. The student is brought face to face with disease and instructed as to its overcoming.

(a) Practical Suggestion.

He is taught how to awaken those forces in his patient that must act in bringing about a condition of health. He is taught the value of suggestion when and how to use it and why it is a potent agency in treating disease. Suggestion as it is applied and taught in the Weltmer Institute is unsurpassed by any course ever offered in this subject. A verification of value of suggestion and the many ways in which it is applied, with highly beneficial results, may be had in the observation of cases under treatment here every day.

Prof. Weltmer's method of applying suggestion is explained by him in his lectures and in the classes so clearly that the student will see, at a glance, the superior methods of Applied Suggestion.

In the treatment of diseased conditions neurotic subjects are especially benefited through this means and many apparently hopeless cases of nervous diseases are rapidly restored to health and vigor by no other means.

Nothing is left undone by Prof. Weltmer and his faculty, in the way of preparing the student and operator to apply suggestion successfully in his future practice.

COURSE OF STUDY.

The student is started on the road to success in a beautiful and noble work for humanity.

In his daily lectures Prof. Weltmer recites many demonstrations from his actual experience, telling how and why certain results reward certain efforts.

(2) ANATOMY.

The necessity of a thorough practical knowledge of anatomy is apparent when the physical structure is to be considered. Minute knowledge of the location, functions and relations of the vital organs must be had before an intelligent attempt can be made to make physical changes in them.

A lecture on anatomy is given each day dealing with the structural life of the body.

Dr. Potter's anatomy is the text used in this course. Beside the regular text, the human skeleton, colored charts, anatomical aids and black board illustrations are used to make clear every detail of the lesson.

(a) Applied Anatomy.

Is treated in lectures at regular periods in the course. The cause and symptoms of disease are considered from the anatomical view point and careful observation of the result of misplaced organs and structures, is made; their functions and relation are also studied in connection.

The purpose of the Applied Anatomy Course is to explain the proper means of re-adjusting deranged structures and restoring to them their proper function and relation. The student is impressed with the fact that the body is normal only when all its structures are perfect in their relation and the functions of each are harmonious.

This branch of anatomy is studied more through the experience of the student and teacher than from a text, the clinics furnishing the widest field for investigation. Careful notebook work proves a valuable aid to the student in this branch.

(b) Descriptive Anatomy.

A general knowledge of anatomy is so necessary that it forms one of the chief branches in the curriculum of study. A skeleton is provided for the benefit of students and osteology is discussed in all its different phases. The frame work of our bodies being well understood, the location of the noble organs of the body are so fully and accurately described by taking up one after another, that the student very soon has a comprehensive knowledge of the normal position and the physiology of all of them.

The clinical instruction, of the treatment of the different organs of the body, is fully explained by treating living subjects before the class and impresses the work so firmly on the mind of the student that he is fully able, when the course is finished, to treat all kinds of disease in a scientific manner.

(3) PHYSIOLOGY.

This science follows very closely that of anatomy; in fact, it is difficult to separate them, the lectures on physiology dealing with the functions of the body and going deeply into pathology with all the varying conditions.

A series of special lectures included in physiology embraces the instructions regarding hygiene and diet, also the importance of consistent exercise, deep breathing, right thinking, etc.

In this course Dr. Brubaker's physiology is the adopted text which is clearly demonstrated by the use of models, experiments, lectures, clinics, quizzes, etc. etc.

(a) Physiology Of The Nervous System.

The physiology of the nervous system as taught in the Institute has been the means of advancing the student further in treating disease without the aid of drugs than any of the recent branches Prof. Weltmer has added to his course.

The position is taken that through the laws of vibration diseased conditions can be reached understandingly, if one understands the physiological action of the cell vibration.

The great cerebro spinal nervous system consists of the brain, the spinal cord and the many nerves that branch therefrom. These nerves convey to and from the brain, impressions that are curative in their actions, and so explained by the professor in charge that even a child can understand why the Drugless Healer places his hand on the human body to bring about good results in disease.

The great sympathetic chain that binds all these different nerves together is also explained, together with the different plexuses of the nerves throughout the body. It is clearly shown that diseased conditions arise from an irregular vibration of the nerve cells to the parts supplied, and how a single treatment often arouses these dormant cells to renewed action and the patient's strength and health is built up in a short space of time.

The size and shape of these cells are thoroughly discussed and their action fully explained in passing from the nerve extremity to the brain and the communication sent out from the brain to the different parts of the body.

The difference between electric and galvanic currents as compared with the vibrations of the trained operator are also fully explained in such a manner that the subject is fully comprehended in all its details by each and every student.

(b) Physiology Of The Circulation.

The lectures fully set forth the value of the circulating medium in eradicating and curing many diseased conditions that have been supposed to be incurable for a long period of time, and it is fully explained and demonstrated to the students of this philosophy that with the proper effort the circulation of the blood can be fully equalized throughout the body and parts which are suffering for this nutritious food can be supplied by the operator, acting through the vaso motor system, relaxing the capillary blood vessels throughout the body.

Many supposed heart troubles are entirely relieved by the system of general treatment that is used daily in this Institute. The effects of this treatment on the circulation are of a permanent nature and the patient does not relapse into former conditions as he usually does when tonics and stimulating medicines are taken to correct the circulation.

The effect of this treatment on the circulation is very soon recognized in cases of indigestion and constipation. It creates a normal action of the stomach and bowels. The appetite is also restored.

(4) PATHOLOGY.

This particular phase of the science is especially valuable to the healer when the patient commences to show symptoms of recovery, as his condition may be understood and treated in a way which would be impossible under a system which required less skill.

He is taught the pathological changes occurring in the body during every stage in the progress of the most diverse diseases. Recitations and lectures occur throughout the entire course and cover the ground of special pathology.

The subject is not handled according to the regular texts which record the changes under medical treatment, but it is studied through a special text used exclusively by the Weltmer Institute.

(a) Symptoms.

In connection with pathology is given a course in symptomatology. In the treatment given by the Weltmer Institute symptoms are of secondary importance, being only the evidence of delayed or premature functions, their only importance being to assist in diagnosis as they indicate the nature and location of the deranged structure.

(b) Physical Diagnosis.

The chair of physical diagnosis in the Weltmer Institute is attracting more attention than probably any other one of the auxiliary courses. Nothing really new is presented outside the ordinary description of diseased conditions with their cause and treatment, but the manner in which it is presented is what makes this part of the work attractive.

The fine details of diseased conditions are not dwelt upon to tire the student but the more important symptoms are fully impressed upon the mind in such a manner that the student is enabled to get quite a thorough knowledge of pathology, in the limited time that he remains in the Institute.

As in pathology, no particular text has been adopted, but several may be recommended merely as references.

(5) THEORY AND PRACTICE.

The fifth, and perhaps the most important of the auxiliary branches is the Clinical course known under the head of Theory and Practice.

The Clinics are held on Wednesday and Saturday morning of each week and are a thorough review of the ground covered in all the branches studied during the past three days.

This field for experience is a very large one. Attending the Weltmer Institute are always people suffering from nearly every form of disease in the various stages, giving the student an excellent field for observation. A room is set aside for the use of the students in which to hold clinics, and during the hour devoted to such practice, every student is required to make a careful report of the cases under observation, noting the cause, location and progress of the disease. The mental state of the patient is also carefully studied. A full report of each case coming under the eyes of every student, is required by the member of the faculty who has this department in charge.

The afternoons of Wednesday and Saturday of each week are given up to clinical lectures. At this hour a patient is brought before the class, the demonstrator gives a careful diagnosis, pointing out the seat of trouble and administers the treatment before the class. He holds himself ready to answer all questions on points not understood by any student.

Very often a number of patients suffering from the same disease, but in different stages, are brought before the class and the minutest details are noted and discussed. Sometimes these patients are turned over to advanced students, the teacher taking the place of the student and quizzing him on every point connected with the case in hand.

At the Saturday clinic the reports of the preceding week are discussed and instructions are given freely to those who do not thoroughly

understand any features of the development of the cases observed. These case reports show a most satisfactory record of cures, among which are both chronic and acute diseases.

The value of these bi-weekly examinations is apparent to every one, as they give experience which would require perhaps years to acquire in any other way. They establish confidence in the student and place him on the sure ground that is so necessary in handling so many of the cases he will encounter in his future practice.

The thoroughness of this branch alone is responsible for its being possible to complete the study in three months. Each clinic is the thorough treatment of the diseases, in their various forms, in organs, nerves or tissues, in which these diseases most often appear, thus making a clinic a complete lesson and enabling the student to enter the course at any time at no disadvantage.

The four auxiliary branches are handled in the same manner as in medical colleges, yet their application in the healing of disease, without drugs is dwelt on with particular force.

In the complete course there are more than three hundred lectures besides the clinics, class meetings and social gatherings. All the above mentioned branches, together with the Weltmer philosophy, make the most complete course ever offered by any school for the price and time consumed in study.

A COMPLETE DESCRIPTION OF THE MAIL COURSE IN DRUGLESS HEALING GIVEN BY THE WELTMER INSTITUTE

The Weltmer Mail Course consists of fifteen lectures, bound in heavy paper covers and divided into three pamphlets. These lectures, or lessons, are written in the simple easy style so characteristic of Prof. Weltmer. They go to the very bottom of the subject of Suggestion—SPECIFIC, THERAPEUTIC, DIRECT, INDIRECT, CONSCIOUS, UNCONSCIOUS TELEPATHIC AND AUTO. In the subdivisions of Suggestion Hypnotic phenomena is demonstrated in its many phases. The following branches are also taught: VITAL MAGNETISM, TELEPATHY, HUMAN ELECTRICITY, MENTAL CONTROL AND THE UTILIZATION OF THE FACULTIES OF THE SUB-CONSCIOUS MIND. The lessons teach the student how to awaken those powers and forces, in his patient, which create and maintain all living things and which are alone able to heal.

The mastery of the principles taught in this Course will not only enable you to keep yourself, your family and friends in the ways of health, but it will also teach you how to get the most out of your efforts and realize, in the fullest measure, your latent possibilities. It lifts you above the present day bondage of fear and the accompanying weaknesses so common to man. A mother can instill, in a son or daughter, the elements of a noble character. She can establish, in her loved ones, a self reliance that makes them natural leaders of men and able to surmount every obstacle in the path of success.

The mind is most easily influenced in the formative stages of childhood and a well guided tendency, awakened in the child, is likely to become a controlling influence in the mind of the man, making for success and perfect development. Let the mother teach her boys and girls to try for the things they desire, believing in their power to get them, and she has started her child out into the world with a heritage worth more than all the millions a successful business career might enable their father to leave them. The mother is responsible for her child's attitude of fear or courage. When she understands the basis principles of these attitudes, there is no question of choice. She is sure to use every influence for the betterment of the child when she knows what to do.

The lessons tell what co-operation is necessary between the healer and the patient and how and why results are obtained.

The text is made plainer by fifteen full page half tones which picture the proper manner of administering treatment to the important nerve centers. These cuts give the Clinical feature that Correspondence Instructions has so long needed. The physiology of the nervous system is clearly taught, together with the anatomy of the body.

The effect of the treatment upon both the nerve and muscular structure is clearly demonstrated by careful descriptions of cases which have come under the author's observation. Rules are given which, if followed out, will bring as unvarying results as those obtained by complying with the laws of mathematics. The author works, continually, from cause to effect and every demonstration is given from his personal experience.

TEXT BOOK.

Supplemental to the fifteen lessons is given a book of 270 pages in which the principles set forth in the Mail Course are elaborated and more complete demonstrations are furnished. In this book the specific treatment for more than a hundred common diseases is fully outlined, making it a most valuable book for reference.

Such a book could only be written by one who had the wide experience of personal contact with many hundreds of patients. Special attention is accorded the instructions pertaining to physical diagnosis and pathology.

In the supplemental text book, Prof. Weltmer tells the student clearly how to diagnosis disease and he indicates the pathological changes following the treatment.

Prof. Weltmer has devoted much of his time to revising, re-writing, adding to and eliminating from his course of instruction, until, today, it stands for everything advanced and practical. The following is a short extract from one of the many hundreds of letters received every month:

Pending investigation, Prof. Weltmer's mail was held, and was released by wire immediately after he appeared before the Postal Department and proved the merits of his science. No fraud order was ever placed upon Mail address to Prof. Weltmer. In the ensuing legal proceeding, the United States Supreme Court passed upon the merits of the method and pronounced it "Legitimate and Lawful."

No additional charge is made for supplemental instructions and the privilege of asking questions is extended over an indefinite period. Prof. Weltmer is always eager to assist his graduates in every way within his power and his advice is freely given when sought.

TREATMENT BY CORRESPONDENCE.

Very similar and not less successful than the teaching of the Weltmer Method by mail, is the department known as the Absent Treatment. It rests on the same foundation principles as the Personal Treatment given in the Sanitarium.

The treatment is not a "cure all" or "fad," neither is it a secret remedy. Simplicity in thought and action is essential. There are no tedious forms of exercise, baths or diets in any way connected with the treatment. Prof. Weltmer's part of the treatment is to place the patient into harmonious co-operation with the creative forces of nature that must be relied upon to restore health.

A peculiar feature of this treatment is that it is wonderfully effective in the diseases of children, when Prof. Weltmer has the co-operation of the parent.

Each case is carefully studied and the course of treatment decided upon which, out of his wide experience, Prof. Weltmer considers most beneficial. The correspondence of each patient is kept separate and his needs are looked after with the same care that is exercised in the treatment given within the doors of the sanitarium.

What are known as general instructions are printed in pamphlet form and furnished to each patient. These instructions deal, particularly, with the principles of right living; they describe the proper attitude of mind most conducive to health. Prof. Weltmer's letter, accompanying the general instructions, indicates the physical manipulation and gives special instructions to enable the patient to get the full benefit of the treatment.

In order to keep in close touch with his patients, and to better understand each phase of the case in hand, Prof. Weltmer requires a conscientious report each week of the progress of his patients. These reports may be made as much oftener as the patient likes, and he may rest assured that each report will receive careful and prompt attention.

The time required in taking treatment does not exceed 30 minutes, twice each day, but it is absolutely necessary that the patient devote this amount of time to the treatment, in order that the progress may not be arrested until permanent relief is given.

The home treatment does not exclude other forms of treatment. It may be taken at the same time the patient is taking medical treat-

ment. It operates with the same sureness when taken in connection with other treatments as when it is the only means employed.

THE HEALING HAND.

By Prof. S. A. WELTMER.

When Harvey discovered the circulation of the blood, both interest and consternation resulted in the ranks of the medical profession. Interest on the part of those who desired to learn more of the means of alleviating humanity and consternation on the part of the conservative element who wished to maintain their prestige and who so bitterly opposed any innovation upon the established thought and practice. The discovery of vaccination, by Jenner, had a like effect, but later the most important, in fact the all important to material sciences, was the discovery of the cellular construction of all animate bodies and especially the cellular construction of the human body.

Following the discovery that the human body consists of cells was the further discovery of the nature of these cells and that particular quality of movement which indicated a normal living condition.

In applying the positive pole of the battery on the patient's



"Medicine is not being prescribed to anything like the extent it was even a few years back," declared Dr. J. Stenson Hooker yesterday. "Further, when it is prescribed, it is now given in a more convenient and palatable form. Our manufacturing chemists have of late produced all kinds of medicines in the shape of tablets, capsules, synthetic remedies, and so on.

"I believe that before homeopathy came into existence the questions of diet, hygiene, and the general management of the sick were flagrantly overlooked. I will not discuss the efficacy of homeopathic principles, but will merely maintain that the system tended to make us employ more refined and attenuated medicines.

"The potency of human magnetism will have to be acknowledged by physicians sooner or later. The cures wrought by the saints and others of the laying on of hands are well authenticated, and the day is not far distant when it will be generally admitted that in proportion as man becomes more spiritualized, so will he become possessed, of an increasing power to heal.

"Then we have the various nature cures physical exercises, hygiene generally and electricity. All these are widely advocated and employed at the present day, and no doubt rightly so.

"But the point to be arrived at if possible is, shall we depend upon these various agents entirely in the future? Or will it ever be acknowledged that there are still other forces which we have as yet barely tapped, but which will prove still more powerful than the purely physical ones I have named?"

ORIGINAL EXPLANATION OF ABSENT TREATMENT METHOD

BY PROF. S. A. WELTMER.

The purpose of this article is to give a clear and concise idea of what is termed "Absent Treatment." I dislike the term "treatment," and use it simply because persons suffering from bodily ailments have been educated to term whatever is done for them or by them to alleviate such suffering as "treatment."

I want it clearly understood that the Weltmer Home Method of Healing is a series or system of instructions, which, if carefully and persistently followed, will change the condition of one's life in whatever way is desired. The proposition of Weltmerism is based upon the principle that the mind controls the body through the exercise of the will; that the will can be exercised only in one way—that is, by relying upon it. Every effort of the will which brings to the patient health and happiness or prosperity is a compliance with law.

The power to heal disease is not in man; there is a First Great Cause, an intelligent Cause, an immutable law, which governs the lives and actions of all things. This law operates constantly through man, with our knowledge or without it. If without our knowledge, we are subject to all the adverse conditions that may assail us, and helpless so far as ameliorating these conditions is concerned.

A knowledge of this law and perfect compliance with it gives us mastery over disease, over adverse conditions, and this knowledge constitutes our power and compliance with it builds us up. However, in this law "we live and move and have our continual being."

By a careful investigation we find that in everything there is a principle that we call Life. In the apparently inanimate rock, in the vegetable and animal kingdom, of which latter kingdom man stands at the head, we find this life that stimulates the body or plant in which it exists, but we note that the moment this departs from its habitation, that moment the body once occupied is dead. We call this Life principle the First Great Cause, the Creator, the Law, the Law of Nature, God.

Man uses this force either consciously or unconsciously all the time, and man is said to be created in the image and likeness of God. This same Law, operating through man, causes him, when he exercises the executive part of himself, which is the Will, to move about, to work with his hands or to think with his brain, and this we call voluntary action. Without the knowledge of how it is done, this Law operates through man, keeping his heart in motion, his lungs inhaling and exhaling, the pores of the skin constantly exuding the impurities of the body and absorbing life, and this we call involuntary force.

By fully understanding the nature of man we find that what we once considered involuntary force becomes Voluntary Force. The purpose of the healer is to bring into action this Law, to instruct the patient so he will know how to live in harmony with this Law which, if properly observed, will enable us to use this power to the up-building or rebuilding of the human body. The valuable feature of this Law is that it operates regardless of man's knowledge of its existence, or of his knowledge of how it operates. Man has control of his physical force, just in proportion to his understanding of this Law, and its manner of operation. His body becomes stronger and healthier as he obeys the Law, and weaker and more diseased as he disobeys it.

The purpose of Weltmerism is to give an understanding of this Law and how it acts. The Law operates through all things, whether for the purpose of building up healthy bodily tissues, or for eliminating disease, or alleviating pain. Man, however, having placed himself without the pale of this Law, finds it extremely difficult to get back again. Disease and pain are registered upon his physical organism, and he can not think the thought that will set him free. Here is where the healer comes in. The healer, not being afflicted can think the right thought. The sufferer can assume the receptive attitude of mind toward his healer. Then, when two minds agree, whatever is desired by them in the way of healing is done unto them of the "Father which is in Heaven." See Matt. 18:19. This agreement of two minds is the condition under which the Law takes effect again, having been transgressed. It is not the force that the healer sends out that does the healing act.

The healer does not heal the patient. The patient does not heal himself. The Law under which they act is complied with. This condition is the agreement of two minds, as I have above stated. 

Modern Equipment of The Weltmer Institute.

Next door to the main building is a structure called the annex where meals and lodging may be had at a reasonable rate. This building contains fifteen rooms, is steam heated, has hot and cold water, baths and all the conveniences of a modern hotel.

The instruction department of the Institute is supplied with skeletons, charts, anatomical aids, reference books, black boards and quizzes.
