## 37th ANNUAL CONVENTION NATIONAL SPIRITUALIST ASSOCIATION

OCTOBER 14-19, 1929

## Points of Special Interest Historic Boston

**T**HE visitor whose time in Boston is limited will find the following list of leading points of interest helpful in arranging an itinerary. Space will not allow the enumeration of a complete list. Yet there are many historic places that every visitor to Boston ought to see.

### Arnold Arboretum and Museum

Forest Hills. The Tree Museum of Harvard University. One of the most beautiful public gardens in the world; contains the largest collection of trees and shrubs in America, conveniently arranged for study. 210 acres. Open daily from sunrise to sunset. Free. Automobiles not admitted.

### "Ye Old Blake House"

Edward Everett Sq., Dorchester. Built 1648. Occupied by Dorchester Historical Society. Colonial and Civil War relics. In front of the house is the old Dorchester Mile Stone, 173 years old.

### Boston Common

This tract of land, containing nearly fifty acres, was bought in 1634 by Governor Winthrop and others from William Blackstone, who held his title by a right of possession gained prior to the settlement of Boston in 1630, and was set apart for "common use as a cow pasture and training field." In the Common is the famous "Frog Pond." Soldiers' Monument crowns Flagstaff Hill, where British artillery was stationed during the siege of Boston, when troops were quartered and entrenched there; from what is now Park Square the British embarked for Lexington April 18, 1775. On the Common the British mustered before Bunker Hill. Here mustered contingents for colonial expeditions against Louisbourg and Quebec. Here many Massachusetts regiments assembled prior to going to the front in the Civil War.

### Boston Massacre

State Street, corner of Exchange. The site of the riot between a mob of townspeople and the British guard, March 5, 1770. It is marked by a circle in the paving and by a tablet on building on west corner of Exchange Street.

### Boston Stone

A round stone embedded in wall of building in Public Alley 102, near corner of Marshall St., on Hanover St. Inscribed "1737." Originally a paint miller, imported from England, 1700.

### Bunker Hill Monument

Monument Sq., Charlestown. A granite obelisk, 221 feet high on Breed's Hill, within the lines of the American redoubt which was the center of the Battle of Bunker Hill, June 17, 1775. Revolutionary relics. General Lafayette assisted at the laying of the corner stone, June 17, 1825. Winding stairway of 294 steps to top. Open 9 a. m. to 4 p. m. Admission 25 cents.

### "Boston Tea Party"

Site of Griffin's Wharf, Atlantic Avenue and Pearl Street, off of which were the ships whose cargoes of tea were emptied into Boston Harbor by American patriots on the night of December 16, 1773, as a protest against the tyrannical tax imposed by King George of England. Site of wharf marked by tablet in wall of building.

### Dorchester Heights

G St., South Boston. Monument marks spot where Washington planted batteries which drove the British troops out of Boston on March 17, 1776.

### Faneuil Hall

Faneuil Hall Sq. "Cradle of Liberty." Built 1742 by Peter Faneuil and given to Boston as a town hall. Burned in 1761, rebuilt 1762. Center of Revolutionary movement in Boston and the colonies. Used by the British officers as a playhouse during the siege of Boston. Enlarged 1805, from Charles Bulfinch's plans. Hall has many historic paintings and portraits. Armory on third floor has Military Museum and Library. Hall open week days 9 a. m. to 5 p. m.; Saturdays 9 a. m. to noon. Admission free.

### First Church in Boston

Corner of Berkeley and Marlboro Sts. Contains tablets and statues of Winthrop, Cotton, Dudley, Johnson and many of the founders of Massachusetts Bay Colony, together with various memorials to people of more recent prominence in the Commonwealth. Open daily from 9 a. m. to 5 p. m.

### First Church in Roxbury

Elliot Sq. Open through the summer, free to visitors, from 1 p. m. to 3 p. m. The church of the Apostles Elliot, whose chair is on exhibition. A number of tablets have been placed in memory of the earliest and later worshippers.

### First Post Office in American Colonies

Established by order of the General Court on Nov. 5, 1639. Location is indicated by a tablet in the doorway of Boston Globe Building, 244 Washington St.

### Franklin's Birthplace

17 Milk St. Site of birthplace of Benjamin Franklin covered by building occupied by Boston Transcript.

### The Great Elm

Boston Common, Tremont Street almost opposite the Oliver Ditson Music Company. More ancient than Boston itself. Scene of many executions in the Colonial days. Ann Hibben, the witch, executed here in 1756. The present elm is a branch of the original.

### Green Dragon Tavern

80-86 Union St. Used as a tavern and lodge rooms by St. Andrew's Lodge of Freemasons, where meetings of the patriots were held previous to the Revolution. Tablet marks site.

### John Hancock House

Beacon Street, two doors below State House, No. 29. Site of John Hancock House, built 1737, torn down 1863.

Among guests entertained by Hancock were General Lafayette, 1781 and General George Washington, 1789.

### Harrison Gray Otis House

214 Lynde St., corner of Cambridge. Built 1795, and now owned by the Society for the Preservation of New England Antiquities and occupied as headquarters. Fine museum of furniture, pottery, glass, articles of costume and miscellaneous antiques. Free to members.

### King's Chapel

Tremont and School Sts. First chapel built in 1686, present one in 1749. Old English architecture. First Episcopal church in New England. Here British officers worshipped during siege. Became First Unitarian Church in United States 1785. Open daily 9 a. m. to 4 p. m.

### Liberty Tree

Washington St., opposite Boylston St. Tablet on building marks site of the famous old Liberty Tree, planted in 1646 and cut down by the British in 1775. Stamp Act meetings were held here and Tory leaders hanged in effigy.

### Massachusetts Historical Society

1154 Boylston St., corner of the Fenway. Library open daily. Has a rare collection of objects of historic interest. Open on Wednesdays, 2 p. m. to 4 p. m. Admission free.

### Navy Yard

Chelsea St., Charlestown. In continuous operation from 1780. Contains 110 acres. Frigate Constitution—"Old Ironsides"—built in 1794 is at Yard. Open to visitors.

### Old North Church

187 Salem St. Oldest church in Boston. Built in 1723. From belfry of this Church, on night of April 18, 1775, were hung lanterns which signalled Paul Revere that the British troops were marching on Lexington and Concord. Admission free to Church, fifty cents to go to the belfry.

### Old South Meeting house

Washington and Milk Sts. Society formed 1669. Present house built 1729. Here the men of the town gathered to protest against forcing Massachusetts citizens into the English Navy, to demand withdrawal of British troops, and to decide the fate of the hated tea tax. Here were commemorated, 1771-1775, anniversaries of the Boston Massacre, with orations by Lovell, Hancock, Church and Warren. Used by the British as a riding school during the siege of Boston. Restored and used for church

### Old State House

Washington St., head of State St. Here the first Town House was built, 1657, in the earliest marketplace of Boston. Burned in 1711. The present building was built in 1713, burned in 1747; then rebuilt, the walls of the former building being utilized. Here met colonial courts and legislators, the town and city governments, and the General Court of the Commonwealth. Here were the whipping post and the stocks. Used as City Hall of Boston 1839 to 1840. Building restored in 1882. Large collection of relics. Open daily 9 a. m. to 4 p. m. Saturdays, 9 a. m. to 1 p. m. Admission free.

### Old West Church

Cambridge and Lynde Sts. Now used as a branch of the Boston Public Library. Built 1806 on site of edifice of 1757, which was a signal station for Americans and a barracks for the British during the siege. Open a. m. to 10 p. m. Sundays noon to 9 p. m.

### Robert Treat Paine Tablet

Marking site of home of this signer of the Declaration of Independence, on First National Bank Building, Milk St., at Federal and Devonshire Streets.

### Park Street Church

Corner Park and Tremont Sts. Erected in 1810 on site of the granary where sails of the United States frigate "Constitution" were made. Gunpowder stored in basement in 1812 gave Church the name of "Brimstone Corner." Here on July 4, 1832 "America" was first publicly sung.

### Paul Revere House

19 North Sq. Built 1660. Restored 1905. Home of Paul Revere 1770-1800. Open week days and holidays, 10 a. m. to 4 p. m. Admission 25 cents.



## Points of Special Interest Metropolitan Boston

**I**NCLUDED within a radius of twelve miles from the State House are some forty cities and towns which, although independent of Boston politically, share in the benefits, and the expenses of maintaining a communal sewage system, water supply, etc. Among the largest of these cities and towns which make up Metropolitan Boston are Cambridge, Brookline, Somerville, Newton and Quincy. This bigger and suburban Boston is the real Boston, and not the Boston which census figures give.

### Christ Church

On Garden St., Cambridge opposite the Common, 1759-61, this church being Tory property, was used as a barracks by the provincial troops during the siege of Boston and the lead pipes of the Organ were melted into bullets. Washington held services here on New Year's Eve, 1775.

### Cradock House

On Riverside Ave., Medford, this was the first brick building erected in the Massachusetts Bay colony and was built by Mathew Cradock, Governor of the Colony. It is the oldest brick building now standing in New England and perhaps in the United States.

### Fairbanks House

Situated at Dedham and erected in 1636, it lays claim to being the oldest wooden house in America. The Furber bricks and tiles found in it were brought from England by the family.

### Harvard University

Upon its site at Harvard Square, Cambridge, this University was founded in 1636. It is the oldest and most distinguished school of learning in America.

### Harvard Stadium

Located near Harvard University, this athletic field, the first of the sports stadia in this country, has normal seating capacity of 25,000 people with arranged maximum capacity for 45,000 people.

### Hutchinson House

Situated in Milton on the site of the original house of Governor Hutchinson, the last Royal Governor of Massachusetts (1771-1774) who was born in Boston in 1711 and died 1780.

### Longfellow's House

On Brattle St., Cambridge, in 1759 by Colonel John Varral, a Tory, and purchased in 1793 by Andrew Craigie, this house later came into possession of Henry Wadsworth Longfellow soon after 1835 and his daughter Miss Alice Longfellow now occupies it.

### Lowell's House

Upon its site on Elmwood Avenue, near Mount Auburn Cemetery, Cambridge, this house was erected 1763-67. During the battle of Bunker Hill, it was used as a hospital and later by Benedict Arnold as his headquarters for three weeks. James Russell Lowell was born in 1819.

### Mount Auburn Cemetery

Situated on Mount Auburn St., Cambridge, the earth here embodies the remains of distinguished and honored dead, among others: James Russell Lowell, Oliver Wendell Holmes, Charles Sumner, Edward Everett, Louis Agassiz, Philips Brooks. Here also stands the famous Sphinx. The cemetery is noted for its natural beauty.

### Norumbega Tower

Located on the banks of the Charles River at Waltham, marking the site believed to be where the Ancient Norse City of Norumbega was situated.

### Old Powder House

Located in Somerville and erected in 1720 as a windmill for grain. Later in 1774, General Gage stored 250 half-barrels of powder that had been stored there by the American Colonists.

### Prospect Hill

Somerville. Reported to be the scene of the first unfurling of the American flag.

### Revolutionary Fort

Upon its site in Somerville now stands the Central Library building. The Hessian prisoners taken at Burgoyne's surrender were confined in the fort.

### Royall House

Erected in Medford in 1738, this house is one of the most historic in New England. A building adjoining was originally the slave quarters and is the only structure of its kind remaining in Massachusetts.

### Washington Elm

Tablet at corner of Garden St. and Massachusetts Ave., Cambridge, marks location of elm under which General George Washington assumed command of the American Army July 3, 1775. Collapsed of old age, 1923.

### Watertown Arsenal

Located on Arsenal St., Watertown, and occupying 100 acres, the government has centralized here a complete equipment of machinery devoted to the manufacture of artillery, projectiles and gun carriages. Permission to view the Arsenal may be obtained from the Commandant's office.

### Wendell Phillips Monument

In the town cemetery, Milton, over the grave of Wendell Phillips who was born in Boston in 1811 and died February 2, 1884.

## Nearby Points of Interest

**NORTH SHORE** — Gloucester, Magnolia, Marblehead, Salem, Swampscott

**T**HE North Shore embraces that portion of the Massachusetts coast extending northward from Boston to Gloucester, early settled at Cape Ann. This territory, in the direction of Salem by colonists from the mother country, and elsewhere by the more adventurous and enterprising spirits of the Boston colony, was once dotted with thriving villages whose inhabitants engaged in shipping and fishing.

Time has effected many changes. Today Gloucester maintains its original character as a fishing port. The other towns have been largely transformed into industrial centers or summer resorts.

### Amesbury

Home of John Greenleaf Whittier, the poet. Born in Haverhill 1807. Died Amesbury, 1892.

### Gloucester

A celebrated fishing port. Largest curer of salt fish in the country, producing 25,000 lbs. of this commodity per day.

### Haverhill

John Greenleaf Whittier, the American poet, was born here in 1807. Died in Amesbury 1892.

### Ipswich

Rev. Nathaniel Ward, one of the original settlers, was the compiler of "Body of Liberties," first code of laws of the Massachusetts Colony.

### Magnolia

Rafe's Chasm and the Reef of Norman's Woe claimed to be the scene of Longfellow's poem, "The Wreck of the Hesperus."

### Marblehead

Willard's famous painting "The Spirit of '76" or "Yankee Doodle" hangs in Abbott Hall. Old Powder House built 1755, at outbreak of the French and Indian wars for the storage of ammunition. Used for storage of powder during Revolutionary War and the War of 1812.

### Newburyport

Birthplace of William Lloyd Garrison, abolitionist. Born December 12, 1804. Died in New York, May 24, 1879.

### Rockport

(Pigeon Cove.) The old castle, claimed to have been built about 1640. Witch House built 1692 by two men from Salem as a safe retreat for their mother who had been condemned as a witch.

### Salem

"House of Seven Gables," built about 1669. Witch House built before 1675. Town House built before 1774, where met the last General Assembly of the Province of Massachusetts Bay and the first Provincial Congress. Birthplace of Hawthorne, American poet, born 1804, died 1864. House dates from before 1692 and belonged to Hawthorne's grandfather after 1772.

### Swampscott

First public highway maintained by the State in the United States. Constructed about 1631, from Lynn and Marblehead.

**SOUTH SHORE** — Quincy, Plymouth, Duxbury, Provincetown

**T**HAT great expanse of coastline running southward from Boston to the tip of Cape Cod comprises what is known as the South Shore. Here the visitor may view some of the places of deep historical interest to every American, such as Plymouth and Provincetown. Here he may find some of the most beautiful estates in eastern Massachusetts.

### Barnstable

James Oles, American statesman, born in 1725. Died 1783.

### Duxbury

Home of Elder Brewster, Miles Standish, John and Priscilla Alden, of Plymouth Colony. Standish Monument, erected to the memory of Miles Standish, stands on Captain's Hill. House built by the first John Alden, in which he died 1687. He was born in England in 1599.

### Eastham

Where first Indian was killed in encounter between the Indians and the Pilgrims of Plymouth County.

### Hingham

Old Ship Church with pyramidal roof and belfry dating from 1631; oldest existing meeting house in the country. Town mill turned by the ebb and flow of the tides, bearing date 1643, still standing.

### Kingston

Huge boulder and tablet mark site of home of William Bradford, the first Pilgrim Governor.

### Marshfield

Site of Daniel Webster's home. Born in Franklin, New Hampshire, January 18, 1782. Died in Marshfield, October 24, 1852. Buried in small cemetery (Burial Hill) in Marshfield.

### Plymouth

National Monument to the forefathers was dedicated August 1, 1889. Plymouth Rock—December 1620. On burial Hill the sites of the old fort built in 1621, and the watch tower built in 1643 are marked; also the graves of Governor Bradford and other early settlers.

### Provincetown

Peregrine White, buried here, born on the Mayflower in Provincetown Harbor, December 1620, the first white child born in America. Pilgrim Memorial Monument erected on Town Hill in 1910.

### Quincy

Birthplace of President John Adams. Born in Quincy (formerly Braintree) in 1735, died July 4, 1826. President John Quincy Adams, born in Quincy (formerly Braintree) July 11, 1767, died in Washington, 1848. In the crypt of the Stone Temple lie the remains of Quincy's two Presidents, John Adams and John Quincy Adams and their wives.

First railway built in the United States, the cars being pulled by horses. Constructed in 1826 to haul the granite for Bunker Hill Monument from the West Quincy quarries to tidewater three miles away.

### Scituate

Well curb where hung the Old Oaken Bucket that inspired Samuel Woodworth to compose his time-honored poem.

## Lexington, Concord, Danvers, Sudbury

**L**EXINGTON and Concord, the scenes of some of the most striking events in American History, are today the Mecca of thousands of visitors from all parts of the country.

On Lexington Green the first skirmish of the Revolutionary War took place. John Hancock and Samuel Adams were sleeping in that town on the night of April 18, 1775, when Paul Revere rode by to warn his countrymen.

At Concord Bridge was fired the shot "heard round the world."

### Emerson House

At Concord. In this house, Ralph Waldo Emerson, the American poet, lived and died. He was born in Boston, May 25, 1803 and died April 27, 1882.

### Hancock-Clarke House

Built at Lexington in 1698 and enlarged in 1734, this house was occupied by the Revs. John Hancock and Jonas Clarke from 1698 to 1805. John Hancock and Samuel Adams were staying here April 18, 1775 when Paul Revere rode into town warning of the approach of the British. The contents of the house are of historical interest and contain many objects illustrating the customs of the time. These are exhibited daily from 11 a. m. to 4 p. m. and Sundays 2 p. m. to 4 p. m. Admission free.

### Minute Man Monument

At Lexington, representing Captain John Parker as he appeared on the morning of April 19, 1775, commanding the 60 or 70 minutemen who hastily gathered on the "Green" at the sound of the bell to oppose the British Regulars sent from Boston.

### Munroe Tavern

Lexington. Built in 1695. Used by Earl Percy April 19, 1775 as headquarters and hospital. Gen. Washington was here in November, 1783. Open week days 9:30 a. m. to 5 p. m. Sundays 2 p. m. to 5 p. m.

### Minute Man Statue

At Concord, French's bronze statue of the Minute Man stands in commemoration of the Battle of Concord, April 19, 1775 where "the shot heard round the world" was fired.

### Sleepy Hollow Cemetery

Situated on Bedford St., Concord, in this hallowed ground rest many of Concord's illustrious authors—Nathaniel Hawthorne, Ralph Waldo Emerson, Channing, Henry Thoreau and the Alcotts.

### Hooper or Collins House

At Danvers, General Gage had his headquarters in this house during summer of 1774.

### Putnam House

Danvers. General Israel Putnam, American Leader during the Revolutionary War was born in this house in 1718 and made his home here. He died in 1790.

### The Concord Grape

Home of the original Concord grape vine which is still in existence. May be seen on the main State Road enclosed in a large arbor within plain view of the highway.

### The Revolutionary Monument

At Lexington in 1799 in memory of those gallant martyrs who gave their lives in the opening of the Revolutionary Drama.

### Capture of Paul Revere

Lincoln. Tablet marks site of capture of Paul Revere by British soldiers on the night of April 18, 1775.

### Wayside Inn

Sudbury. Originally called the "Red Horse." Here dwelt the immortal Henry Wadsworth Longfellow at the time he wrote the "Tales of a Wayside Inn." Built in 1686. Now owned by Henry Ford.

## National Spiritualist Association

THE National Spiritualist Association, parent body of twenty-four state Associations and over six hundred local societies and churches, was organized in the city of Chicago, Ill. in the month of September, 1893, at which time a constitutional convention was held, there being one hundred and sixty-two delegates present from twenty-four states and from the District of Columbia, the following states being represented.

Arizona, California, Colorado, Connecticut, Florida, Illinois, Indiana, Iowa, Kansas, Kentucky, Massachusetts, Minnesota, Missouri, Michigan, Nebraska, New York, New Jersey, New Hampshire, Ohio, Pennsylvania, Texas, Tennessee, Washington, Wisconsin, and the District of Columbia.

At this convention Mr. Harrison D. Barrett was elected unanimously to the office of President of the Association and Mrs. Cora L. V. Richmond was elected unanimously, Vice President.

Responding to applause given at time of his election, Mr. Barrett said in part as follows: "It is not my purpose at this time to waste valuable time of this convention in speech making, but I must thank you for this high honor you have conferred upon me, for this additional mark of your confidence and esteem. To be elected the first President of a legally incorporated National Organization of Spiritualists of the United States of America, I deem the highest honor ever conferred upon Mortal Man. I pledge you my earnest endeavor to work for Spiritualism in fair weather and stormy times as much as my feeble ability will enable me to do; pledging you that the interests of this Association shall be my interests, and this religion the purest and noblest ever vouchsafed to man, shall be advanced in every possible way for the highest good of all mankind. It is the eternal truth, and by standing together as a people, in the same spirit that prevails in this convention, we can redeem the world from theological bondage, and spread the clear white light of purity from the sun of Spiritualism over all the earth, through the Mediumship of our earnest workers, expressed through the Divine Law of cooperation in a National Association."

Mr. Harrison D. Barrett served the National Spiritualist Association, as its President from the time of its organization in 1893 until the time of the fifteenth annual convention of the Association which was held in the city of Washington, D. C. in 1907, at which time Dr. George B. Warne, was elected to this office.

Dr. George B. Warne, second President of the Association elected in the year 1907 remained in that office, serving the Association most loyally and efficiently until the time of his transition into the Spirit World, January 22nd, 1925.

At the time of the passing onward of Dr. Warne, Mrs. Joseph P. Whitwell, by virtue of her office as Vice President, succeeded to the office of President and was afterwards elected to that office for a term of three years at the thirty-fourth annual convention held in Toledo in 1926.

Valuable among the publications issued by the National Spiritualist Association is the Spiritualist Manual, copies of which are owned by many hundreds of Spiritualists throughout the United States and in foreign countries.

This book is especially valuable, containing as it does statements of the fundamental principles of philosophy and religion of Spiritualism, as interpreted by the National Spiritualist Association. Within its pages also will be found quotations and statements from the bibles of various ages of the world also quotations from writings of sages, seers, prophets, scientists and poets, which are most valuable and convincing.

The Spiritualist Hymnal, published also by the National Spiritualist Association, is a compilation of Spiritualist Hymns, set to suitable and inspiring music, which is in use in most Spiritualist Societies all over the Country and is one that is used and enjoyed in the homes of many who are capable of enjoying its sentiments and spiritual harmony.

"The National Spiritualist" is a monthly magazine published by the National Spiritualist Association, for the welfare of the organization and for the information of all members of the Association. It carries information of the doings of local and state associations and under the care of its capable editor, Mrs. Mary Ridpath-Mann are printed instructive and interesting articles upon the science, the philosophy and the religion of Spiritualism.

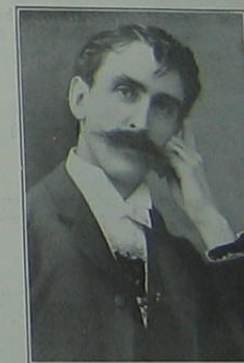

## Declarations of Principles

1. We believe in Infinite Intelligence.
2. We believe that the phenomena of nature, both physical and spiritual, are the expression of Infinite Intelligence.
3. We affirm that a correct understanding of such expression and living in accordance therewith, constitutes true religion.
4. We affirm that the existence and personal identity of the individual continue after the change called death.
5. We affirm that communication with the so-called dead is a fact, scientifically proven by the phenomena of Spiritualism.
6. We believe that the highest morality is contained in the Golden Rule: "Whatsoever ye would that others should do unto you, do ye also unto them."
7. We affirm the moral responsibility of the individual, and that he makes his own happiness or unhappiness as he obeys or disobeys Nature's physical and spiritual laws.
8. We affirm that the doorway to reformation is never closed against any human soul here or hereafter.

Adopted by N. S. A. Convention, Sec. 1 to 6 at Chicago, Ill., October 1899; Sec. 7 to 8 at Rochester, N. Y., October 1909.

We are indebted to the Spiritualist Manual, an official publication of the N. S. A., for the above Declaration of Principles, Definition and General Outlines of Spiritualism.

## Definitions

Adopted by the

National Spiritualist Association

October 9, 1914, and October 24, 1919.

1. Spiritualism is the Science, Philosophy and Religion of continuous life, based upon the demonstrated fact of communication, by means of mediumship, with those who live in the Spirit World.
2. A Spiritualist is one who believes, as a part of his or her religion, in the communication between this, and the spirit world by means of mediumship, and who endeavors to mould his or her character and conduct in accordance with the highest teachings derived from such communication.
3. A medium is one whose organism is sensitive to vibrations from the spirit world, and through whose instrumentality, intelligence in that world are able to convey messages and produce the phenomena of Spiritualism.

"Spiritualism Is a Science" because it investigates, analyzes and classifies facts and manifestations, demonstrated from the spirit side of life.

"Spiritualism Is a Philosophy" because it studies the laws of nature both on the seen and unseen sides of life and bases its conclusions upon present observed facts. It accepts statements of observed facts of past ages and conclusions drawn therefrom, when sustained by reason and by results of observed facts of the present day.

"Spiritualism Is a Religion" because it strives to understand and comply with the Physical, Mental and Spiritual Laws of Nature, "which are the laws of God."

"As the sunflower turns its face to the light of the sun, so Spiritualism turns the face of humanity to the light of truth."

To protect and encourage spiritual teachers and mediums in all laudable efforts in giving evidence or proof to mankind of a continued intercourse and relationship between the living and the so-called dead. To encourage every person in holding present beliefs always open to re-statement as growing thought and investigation reveal new truth, thereby leaving every individual free to follow the dictates of reason and conscience in spiritual as in secular affairs.

The Illinois State Spiritualist Association was incorporated under the laws of the State of Illinois on July 16, 1896.

The Illinois State Association became a member of the National Spiritualist Association in the year of 1897 and is still affiliated with that great organization.

Perhaps the greatest achievement in the history of the Illinois State Association is that of having established in the State of Illinois the right of mediums to practice mediumship within the state as freely as a priest or minister of the Christian gospel may exercise the functions of their spiritual office.

This has been accomplished in large measure by the assistance and co-operation of the Chicago Spiritualists' League, which was created by the I.S.S.A. for the express purpose of the defense of mediums. It has been through the joint efforts of the State Association and the League that there has been written into the statute law of the State of Illinois a recognition of Spiritualism as a religion, and into the adjudicated law of the State a distinct recognition of the legitimacy of the practice of mediumship and communication, or attempted communication, with the so-called dead.

The association has at the present time 72 auxiliaries, which is the greatest number it has ever had, with a membership of about 3500.

## The Chicago Spiritualists' League

The League was organized in 1904 and Incorporated in 1907, it is an auxiliary to the Illinois State Spiritualist Association and has a membership of 655, of which 236 are Certified Mediums.

The objects of this organization is to extend the influences of the Religion, to promote good will, to protect and defend by lawful means all honest mediums, to work in harmony and conjunction for the furtherance of these objects with the Illinois State Spiritualist Association.

## Maine State Spiritualist Association

THE Maine State Spiritualist Association was organized about 1896. I say 'about', because all the records of the first years of our State Association were destroyed by fire. Harrison D. Barrett, the first President of the National Association, was likewise the first President of our State Association, and held the office some eight years. A. H. Blackington was President for at least one year. Mark A. Barwise was President from 1906 to 1916, and Arthur C. Smith succeeded him, holding the office till 1927. Mary Hobbs Jones has held the office for the last two years.

For the first eight or nine years Viola A. B. Rand was Secretary, but for the last twenty years that office has been held by Mary Drake Jenne.

Maine was one of the earliest State Associations to charter with the National, and has ever been a thoroughly organization State. There is not a single independent society in Maine, all are chartered with the National and are loyal to it, both organizationally and doctrinally. A few local societies have come and gone, but the great majority of societies chartered by our State Association are strong and active after many years of service for the cause. Our active local societies which hold meetings over the large part of each year are located at Bangor, Dover-Foxcroft, Augusta, Belfast, Seabrook, Winterport, Guilford, Portland, Dexter, Milo, Bradford, Stockton, Pittsfield, Brooks & Unity, Waterville, and Rockland. Then there are three old and well established Spiritualist Campmeeting Associations—at Etna, Temple Heights and Madison. Etna is now in its fifty-third year, and has emerged from its disastrous fire of 1922 stronger and finer than ever.

Our platform workers as a class stand high, and all are affiliated with the National. During all the years of organizational work in this State we have had almost no trouble with independent workers. Practically every worker of national prominence has worked at our camps and local societies. Spiritualists as a class stand high in the public opinion of the people of Maine. And they have attained this position by straight out-and-out teaching of the great truths of the science, philosophy and religion of Spiritualism, without truckling to the teachings of Orthodoxy, or aping its paraphernalia of robes or ritual. We in Maine teach what the spirit people teach us, and nothing more and nothing less. All our workers hold certificates which are granted only after careful examination, and many of our younger workers have taken high rank in the educational courses given by the Bureau of Education of our National Association.

In 1911 we established the Harrison D. Barrett Foundation, a memorial fund to that great leader in our movement, which has been gradually growing by gift and bequest, so that in the last few years the income on it has allowed us to keep a State Missionary in the field a part of each year. This work has been of great advantage to the cause in Maine.

We look forward with confidence to the gradual but steady growth of our movement in the State of Maine.

Herrick, Mrs. Emma Boynton, Miss Charlotte Boynton, Mrs. Georgie Staples Davis, Mr. and Mrs. Ernest Randall, Miss Lillian Tobey, Miss Frances Bragg, Harry Lower, Irvin Fifield, Hiram Clark and Arthur W. Stewart as charter members.

The Progressive Spiritualist Society Number 5 was incorporated in 1911. The first president was Harry Lower. The next was Gilbert P. Herrick who held office for nine years in a most efficient uplifting manner for the good of Spiritualism.

Other presidents up to the present, were, William H. Davis, Frank A. Barnard, Dr. Dana Soule, Dr. E. Josephine Cony, Wilfred Pierce, Mrs. Ella Staples, Arthur Wyman Stewart, L. Frank Shute, and the present incumbent, John F. Hawes.

Several years meetings were held twice each Sunday in G. A. R. Hall.

A. W. Stewart was president at the time of the

Society receiving the bequest and he has been truly styled "The Father of the Temple," as it was through his untiring efforts that a suitable lot was procured and the beautiful building was erected.

Others who rendered valuable assistance at that time were C. W. Poor and C. E. Stewart, trustees of the Society, and also serving on the building committee.

Other bequests that have been received at different times were from Dr. H. E. Fields, Dr. E. Josephine Cony, and Mr. Henry Davis.

Donations have been received from time to time from members and friends of whom Mrs. Martha Fifield, daughter of Gilbert P. Herrick, has been most generous.

Two years ago an article was incorporated into the by-laws stating that the Society may have a resident pastor.

Mrs. Edna L. Knowlton was elected to that office which she holds at present.

Mrs. Knowlton is one of Maine's foremost psychics, and is a niece of Mrs. Emma Boynton, through whose efforts the present Society owes its existence.

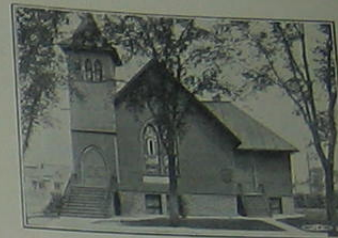
The Society has had a most successful year in gaining many new members of repute, in financial status, and in spiritual advancement.

## First Spiritualist Church ST. PAUL, MINN.

Rev. Ellen Whitwell, Pastor of the First Spiritualist Church of St. Paul, Minn. and Rev. Emma A. Sauer, Assistant Pastor of the same Church, may be considered two pioneer workers in the Cause of Spiritualism.

The Church was organized under the name of the "St. Paul Spiritual Alliance," on April 7th, 1889 and incorporated on August 5th of the same year, and functioned under that name until 1903, when the name was changed to the First Spiritualist Church of St. Paul.

Rev. E. A. Sauer was one of the Charter members and organizers of the society and is the only one still living on the earth plane at the present time.

She has been active in the Church work during all the years since the time of its organization, and since the year 1903, when Mrs. J. P. Whitwell became Pastor of the Church, she and Mrs. Whitwell have been most loyal and efficient workers for the Cause in every way possible.

Their work has not been confined to the Church alone for they have both been leaders and active workers in the Ladies Aid, of which Mrs. Sauer has been President for over twenty five years, and Mrs. Whitwell the Secretary. They have also worked consistently for the State Association, both at Conventions and during the other months of the years, and at National Conventions have always been active and earnest delegates giving their entire time and attention to the business of the convention.

Both are natural born Mediums as their development came to each of them naturally at an early age and since becoming aware of the meaning and significance of Mediumship have always used it for the welfare of humanity and the benefit of the Cause.

## NEW JERSEY STATE ASSOCIATION OF SPIRITUALISTS

This association was organized at Patterson, N. J., January 27, 1912, and incorporated the same year.

Represented by five societies holding services in different parts of the State. Fourteen delegates were present at the first annual meeting.

The late Richard F. Adams of East Orange, N. J., was at that time elected President, which office he retained 6 successive years.

Following one year's retirement he was re-elected and served for another year, making his term of office seven years.

The first secretary, the late Alfred Roberts of Paterson, N. J., held office seven successive years.

Under the able leadership of these officers the cause steadily advanced, and it is largely due to their untiring efforts that the association is now legally recognized as a religious body.

For a number of years the Legislative Committee worked diligently for the adoption of legislative measures at Trenton (State House) where

by Spiritualism would be recognized as a religion.

Through the untiring efforts of Assemblyman Wm. W. Evans of Paterson, N. J., on March 31, 1922, two bills were signed by Governor Edwards, having passed both houses, giving the same recognition, rights and privileges to organized spiritualism as all other religious denominations in the State.

These bills went into effect July 4, 1922.

An adjourned session of the State Convention, held April of the same year convened July 15th and at that time the N. J. S. A. of S was re-incorporated under the Religious Act.

With the adoption of the revised Constitution and By-Laws in conformity to and with the revised National Constitution and By-Laws and the Religious Act.

Organized Spiritualism is steadily advancing in the State of New Jersey. We trust that all other states will soon enjoy the same recognition, that our mutual cause may be thus augmented.

We are fortunate in retaining Assemblyman Wm. W. Evans as Legal Counsellor for our State Association.

The Association is adding each year to their Temple Fund, and expect some day to occupy a building which will be a credit to Organized Spiritualism in this State.

It is this happy combination which makes Mr. Constantine so valuable to the movement. I had the pleasure of making his acquaintance a few days ago when he broke his journey from Buffalo to Washington. The most sensitive psychic would feel instantly at home with him; but behind his sympathy is a firm will which, backed by sound judgment, has made him so much depended upon by his fellow Spiritualists when big issues requiring right decisions have arisen.

## The First Spiritualist Church of Brussels, Door Co., Wisconsin

**W**AS born in 1878, by a small number of families meeting regularly at the home of Constine Delveaux for fourteen years, when other families gathered into the group and met at various homes.

In 1888 two acres of land was purchased for a cemetery plot and is still in use by the Spiritualists.

On August 18, 1893, one acre of ground was bought and the Church erected, with John Everartz as Speaker, Message Bearer, and Healer, who served until his transition in 1900.

Miss Lizzie Dendor, also from Green Bay, taking his place as Speaker for four years, after which Mr. and Mrs. Alex Dewarzeger became the permanent pastor until they moved into Green Bay in 1920. All services up to this time were carried on in the French language.

At present Mrs. Tillie Corbisier, Mrs. Anna Debroux, and Mr. Esidor Lessnise carry on the message in English and Mrs. Alphonse Debroux in French.

In May 1911 the Church became affiliated with the State Association and are a living factor in the upper little peninsular of Wisconsin.



First Spiritualist Church of Green Bay, Wis.

Mr. J. B. Evraets was born July 28, 1832, and died March 28, 1900. He was the pastor and president of the church from the time it was built until his death. He worked unceasingly for the cause and the church, making no charges for his services. Those who knew him proclaimed him the greatest medium Wisconsin ever had. As pastor he was assisted by his brother, Desire Evraets, a medium and prophet; he prophesied the late World War 32 years before its declaration. Upon the death of Mr. J. B. ### THE FIRST SPIRITUALIST CHURCH of Green Bay, Wis.

was founded July 20, 1876, as the Circle of Spiritualists by John B. Evraets, medium, and David Cormier, Frederick Petry, Caroline Petry and Odile Evraets as members. Under the leadership of Mr. Evraets as trance speaker, test medium and healer the circle attracted wide attention resulting in founding of like circles in several adjoining counties. Meetings of the Green Bay Circle were held at the home of Mr. Evraets until the early summer of 1882 when Mr. Harris Duchateau, as principal donor and a great benefactor of the cause, had the present church built on the site it now occupies. The lot was purchased by the members. Later the members in part repaid Mr. Duchateau. The church is of the pioneer type, built of pine on a stone foundation and has a seating capacity of 250.

On March 7, 1903, the Spiritualist Congregation incorporated under the name of the Spiritual and Philosophical Temple of Green Bay. On March 1, 1927, the church affiliated with the W. S. S. A. and was chartered by it. On March 25, 1928, the name was officially changed to the First Spiritualist Church of Green Bay.
